### HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's request for a hearing to protest the denial of claimant's application for Medical Assistance (MA). After due notice, an in-person evidentiary hearing was held on January 11, 2007. Claimant was represented at the hearing by

#### **ISSUE**

Whether claimant meets the disability criteria for Medical Assistance based on disability? FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On 4/20/2005, claimant applied for MA-P with the Michigan DHS.
- (2) Claimant applied for 3 months of retro MA.
- (3) On 8/31/05, MRT denied.

- (4) On 9/9/05, the department issued notice.
- (5) On 12/1/05, claimant filed a hearing request.
- (6) On 10/3/06, SHRT denied claimant. Pursuant to the record being held open, there were two subsequent SHRT reviews denying claimant. The last review was issued on July 25, 2008.
- (7) On August 5, 2008, the undersigned Administrative Law Judge took an extended leave of absence and returned full time on 2/2/2009. On 2/12/2009, claimant's attorney delivered verification of an SSA approval on behalf of claimant showing claimant entitled to Social Security beginning June, 2004. There is no period of time left to review for the substantive issue pursuant to the 1/11/07 hearing and issue herein.

#### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

#### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical

Assistance program as of claimant's April 20, 2005 application and including 3 months of retro MA, if otherwise eligible.

The department is ORDERED to open an MA-P case on behalf of claimant and issue any supplemental benefits to claimant to which she may be entitled if otherwise eligible. The department shall review the case in accordance with its usual policy and procedure.
