HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37, 7 CFR 273.16, MAC R 400.3130, and MAC R 400.3178 upon the Respondent's request for hearing. After due notice, a telephone conference hearing was held on December 2, 2010. The respondent and his daughter were present and testified

<u>ISSUE</u>

Did the Department act properly trying to recover a Food Assistance Program (FAP) overissuance that respondent received due to a Department error?

FINDINGS OF FACT

This Administrative Law Judge, based upon the evidence on the whole record, finds as material fact:

- The Respondent has been a FAP recipient at all times relevant to this matter.
- 2. The Respondent was receiving FAP benefit using a shelter expense of \$514.64. (Department Exhibit 1, pg. 35)
- 3. The Respondent reported that he moved and the new shelter expense was \$160.00 in April 2005. (Department Exhibit 1 pg 32.)

- 4. The Respondent's FAP benefit continued to be calculated using a shelter expense of \$516.64 from April 2005 until March 2006.
- 5. The Respondent was sent a FIA 4358 A Notice of Overissuance on February 5, 2007 indicating an overissuance of \$899.00.
- 6. On February 13, 2007, the Department received the Respondent's Request for Hearing.

CONCLUSIONS OF LAW

The regulations governing the hearing and appeal process for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code, MAC R 400.901 - .951. An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance is denied. MAC R 400.903(1) An opportunity for a hearing shall be granted to an applicant who requests a hearing because of a denial. MAC R 400.903(2)

Clients have the right to contest a department decision affecting eligibility or benefit levels whenever it is believed that the decision is incorrect. BAM 600. The department will provide an administrative hearing to review the decision and determine the appropriateness. BAM 600.

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the FAP program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015.

Department Policy states:

BAM 700 DEPARTMENT POLICY

All Programs

When a client group receives more benefits than they are entitled to receive, DHS must attempt to recoup the overissuance (OI). This item explains OI types and standards of promptness (SOP).

Note: A client or CDC provider may voluntarily repay any program benefits even when there is no overissuance. Refer these situations to the local office fiscal unit.

Definitions The Benefit Recovery System (BRS) is the part of Bridges that tracks all FIP, SDA, CDC and FAP OIs and

payments, issues automated collection notices and triggers automated benefit reductions for active programs.

A claim is the resulting debt created by an overissuance of benefits.

The discovery date is determined by the recoupment specialist (RS) for a client or agency error. This is the date the OI is known to exist and there is evidence available to determine the OI type. For an intentional program violation (IPV) the Office of Inspector General (OIG) determines the discovery date. This is the date the referral was sent to the prosecutor or the date that OIG requested an administrative disqualification hearing.

The establishment date for an OI is:

The date the DHS-4358A-D, Repay Agreement, is sent to the client and for an IPV the date the DHS-4357 is sent notifying the client when the disqualification and recoupment will start.

An overissuance (OI) is the amount of benefits issued to the client group or CDC provider in excess of what they were eligible to receive.

For FAP benefits, an OI is also the amount of benefits trafficked (traded or sold).

Overissuance type identifies the cause of an overissuance.

Recoupment is a DHS action to identify and recover a benefit OI.

BAM 705 Definition

All Programs

An agency error OI is caused by incorrect actions (including delayed or no action) by the Department of Human Services (DHS) or the Department of Information and Technology staff or department processes.

Some examples are:

Available information was not used or was used incorrectly.

- Policy was misapplied.
- Action by local or central office staff was delayed.
- Computer errors occurred.
- Information was not shared between department divisions (services staff, Work First! agencies, etc.).
- Data exchange reports were not acted upon timely (Wage Match, New Hires, BENDEX, etc.).

If unable to identify the type of OI, record it as an agency error.

BAM 705 AGENCY ERROR EXCEPTIONS

FIP, SDA, CDC and FAP

Agency error Ols are not pursued if the estimated Ol amount is less than \$125 per program.

OVERISSUANCE PERIOD

All Programs

OI Begin Date FIP, SDA, CDC and FAP

The OI period begins the first month (or first pay period for CDC) when benefit issuance exceeds the amount allowed by policy, or 12 months before the date the OI was referred to the RS, whichever is later.

To determine the first month of the OI period for changes reported timely and not acted on, Bridges allows time for:

- The full standard of promptness (SOP) for change processing, per BAM 220, and
- The full negative action suspense period. See BAM 220, EFFECTIVE DATE OF CHANGE.

OI End Date

The OI period ends the month (or pay period for CDC) before the benefit is corrected.

OVERISSUANCE AMOUNT FIP, SDA, CDC and FAP

The amount of the OI is the benefit amount the group actually received minus the amount the group was eligible to receive.

The Respondent was receiving FAP benefits in 2005. He properly reported a change of address and mortgage payment the end of April 2005. He submitted proof of the new mortgage payment on May 6, 2005. However, the Department failed to use the new mortgage payment of \$160.00 when calculating the FAP eligibility for the respondent. This resulted in the respondent receiving an overissuance for the time period of April 2005 through March 2006. A department error overissuance is caused by incorrect actions of DHS staff or department processes. Department policy requires the recoupment of the overissuance if it is more than \$125.00. In this case, the total overissuance was \$899.00. Because the overissuance amount is over \$125.00, the Department must take action to recover the overissuance that Respondent received.

DECISION AND ORDER

This Administrative Law Judge, based upon the above findings and conclusion of law, decides that the Department acted properly in trying to recover a FAP overissuance that the respondent received due to Department Error.
