HEARING DECISION

This matter is before the undersigned Administrative aw Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's request for a hearing to protest the proposed closure of claimant's MA and SDA cases at review. After due notice, an evidentiary telephone hearing was held on April 29, 2008.

ISSUE

Did the DHS properly deny claimant continuing eligibility for the MA-P and SDA programs at review?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) At all relevant times prior to the proposed negative action herein, claimant was a beneficiary of the MA-P and SDA programs administered by the Michigan DHS.
 - (2) Claimant's cases were reviewed in November, 2007.

- (3) On 11/13/07, MRT denied.
- (4) On 11/21/07, the department issued notice.
- (5) On 11/28/07, claimant filed a timely hearing request. The department reinstated the action pending the outcome of the hearing. Claimant continues to receive benefits.
 - (6) On 3/14/08, SHRT denied claimant.
- (7) At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Medical records were received and submitted to the State Hearing Review Team (SHRT). SHRT approved claimant's claim for continuing disability on 6/15/09.

CONCLUSIONS OF LAW

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the SHRT determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability, per Program Administrative Manual, Item 600.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition for continuing eligibility at review for the MA-P and SDA programs provided claimant meets the non-medical criteria.

The department is ORDERED to follow the SHRT recommendation for review in July 2012.
