HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on June 12, 2008. The claimant appeared and testified. Claimant was represented by [REDACTED]. Following the hearing, the record was kept open for the receipt of additional medical evidence. Additional documents were received and reviewed.

ISSUE

Did the Department of Human Services (DHS or department) properly determine that claimant is not "disabled" for purposes of the Medical Assistance (MA-P) program?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1) On January 10, 2008, an application was filed on claimant's behalf for MA-P benefits. The application did not request retroactive medical coverage.

- 2) On April 30, 2007, a second application for MA-P benefits was filed on claimant's behalf. That application requested medical coverage retroactive to January 2007.
- 3) On September 19, 2007, the department denied claimant's applications for benefits based upon the belief that claimant did not meet the requisite disability criteria.
- 4) On November 26, 2007, a hearing request was filed to protest the department's determination.
- 5) Claimant, age 36, has a 9th grade education.
- 6) Claimant last worked in approximately 1998 performing unskilled light industrial work. Claimant has also performed relevant work as a waitress, dishwasher, and donut shop worker. Claimant's relevant work history consists exclusively of unskilled work activities.
- 7) Claimant has a history of alcohol abuse, pancreatitis, and hypertension.
- 8) Claimant's mother has served as claimant's full guardian from January 2007 to date.
- 9) Claimant was hospitalized [REDACTED] for altered mental status and debility. Her discharge diagnosis was pancreatitis; ventilator-dependent respiratory failure; pneumonia, status post tracheostomy; normochromic, normocytic anemia; non-ST segment elevation myocardial infarction; electrolyte imbalance; protein-calorie malnutrition; polysubstance abuse; alcohol abuse; leukocytosis; and anemia.

- 10) Claimant currently suffers from coronary artery disease; tobacco abuse; malnourishment; chronic pancreatitis; hypertension; arthritis; major depressive disorder, recurrent with psychotic features; and generalized anxiety disorder.
- 11) Claimant has severe limitations upon her ability to walk, stand, lift, push, pull, reach, carry, or handle; understand, carry out, and remember simple instructions; use of judgment; respond appropriately to others; and deal with changes in a routine work setting. Claimant's limitations have lasted for 12 months or more.
- 12) Claimant's complaints and allegations concerning her impairments and limitations, when considered in light of all objective medical evidence, as well as the record as a whole, reflect an individual who is so impaired as to be incapable of engaging in any substantial gainful activity on a regular and continuing basis.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Federal regulations require that the department use the same operative definition for "disabled" as used for Supplemental Security Income (SSI) under Title XVI of the Social Security Act. 42 CFR 435.540(a).

"Disability" is:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be

expected to last for a continuous period of not less than 12 months
... 20 CFR 416.905

In determining whether an individual is disabled, 20 CFR 416.920 requires the trier of fact to follow a sequential evaluation process by which current work activity, the severity of the impairment(s), residual functional capacity, and vocational factors (i.e., age, education, and work experience) are assessed in that order. When a determination that an individual is or is not disabled can be made at any step in the sequential evaluation, evaluation under a subsequent step is not necessary.

First, the trier of fact must determine if the individual is working and if the work is substantial gainful activity. 20 CFR 416.920(b). In this case, claimant is not working. Therefore, claimant may not be disqualified for MA at this step in the sequential evaluation process.

Secondly, in order to be considered disabled for purposes of MA, a person must have a severe impairment. 20 CFR 416.920(c). A severe impairment is an impairment which significantly limits an individual's physical or mental ability to perform basic work activities. Basic work activities means the abilities and aptitudes necessary to do most jobs. Examples of these include:

- (1) Physical functions such as walking, standing, sitting, lifting, pushing, pulling, reaching, carrying or handling;
- (2) Capacities for seeing, hearing, and speaking;
- (3) Understanding, carrying out, and remembering simple instructions;
- (4) Use of judgment;
- (5) Responding appropriately to supervision, co-workers and usual work situations; and
- (6) Dealing with changes in a routine work setting. 20 CFR 416.921(b).

The purpose of the second step in the sequential evaluation process is to screen out claims lacking in medical merit. *Higgs v. Bowen* 880 F2d 860, 862 (6th Cir, 1988). As a result, the department may only screen out claims at this level which are “totally groundless” solely from a medical standpoint. The *Higgs* court used the severity requirement as a “*de minimus* hurdle” in the disability determination. The *de minimus* standard is a provision of a law that allows the court to disregard trifling matters.

In this case, claimant has presented the required medical data and evidence necessary to support a finding that she has significant physical and mental limitations upon her ability to perform basic work activities such as walking, standing, lifting, pushing, pulling, reaching, carrying or handling; understanding, carrying out, and remembering simple instructions; use of judgment; responding appropriately to supervision, co-workers, and usual work situations; and dealing with changes in a routine work setting. Medical evidence has clearly established that claimant has an impairment (or combination of impairments) that has more than a minimal effect on claimant’s work activities. See Social Security Rulings 85-28, 88-13, and 82-63.

In the third step of the sequential consideration of a disability claim, the trier of fact must determine if the claimant’s impairment (or combination of impairments) is listed in Appendix 1 of Subpart P of 20 CFR, Part 404. This Administrative Law Judge finds that the claimant’s medical record will not support a finding that claimant’s impairment(s) is a “listed impairment” or equal to a listed impairment. See Appendix 1 of Subpart P of 20 CFR, Part 404, Part A. Accordingly, claimant cannot be found to be disabled based upon medical evidence alone. 20 CFR 416.920(d).

In the fourth step of the sequential consideration of a disability claim, the trier of fact must determine if the claimant’s impairment(s) prevents claimant from doing past relevant work. 20 CFR 416.920(e). It is the finding of this Administrative Law Judge, based upon the medical

evidence and objective, physical and psychological findings, that claimant is not capable of the walking, standing, lifting, or personal interaction required by her past employment. Claimant has presented the required medical data and evidence necessary to support a finding that she is not, at this point, capable of performing such work.

In the fifth step of the sequential consideration of a disability claim, the trier of fact must determine if the claimant's impairment(s) prevents claimant from doing other work.

20 CFR 416.920(f). This determination is based upon the claimant's:

- (1) residual functional capacity defined simply as "what can you still do despite your limitations?" 20 CFR 416.945;
- (2) age, education, and work experience, 20 CFR 416.963-.965; and
- (3) the kinds of work which exist in significant numbers in the national economy which the claimant could perform despite his/her limitations. 20 CFR 416.966.

See *Felton v DSS* 161 Mich. App 690, 696 (1987). Once claimant reaches Step 5 in the sequential review process, claimant has already established a *prima facie* case of disability.

Richardson v Secretary of Health and Human Services, 735 F2d 962 (6th Cir, 1984). At that point, the burden of proof is on the state to prove by substantial evidence that the claimant has the residual functional capacity for substantial gainful activity.

In this case, claimant has a history of alcohol abuse, chronic pancreatitis, hypertension, and arthritis. She was hospitalized from [REDACTED] following mental status changes and debility. Her discharge diagnosis included pancreatitis; ventilator-dependent respiratory failure; pneumonia, status post tracheostomy; normochromic, normocytic anemia; non-ST segment elevation myocardial infarction; electrolyte imbalance; protein-calorie malnutrition; polysubstance abuse; alcohol abuse; leukocytosis; and anemia. Claimant's mother has served as claimant's full guardian from January 2007 to date. Claimant's self reports that she

has been alcohol free since her discharge from the hospital in [REDACTED]. Claimant was seen by a consultant internist for the department on [REDACTED]. The consultant diagnosed claimant with heart disease and noted that claimant continues to have chronic shortness of breath and is “still malnourished.” Claimant was seen by a consulting psychiatrist for the department on [REDACTED]. The consultant diagnosed claimant with major depressive disorder, recurrent with psychotic features and generalized anxiety disorder, chronic. The psychiatrist opined that claimant was unable to manage her own benefits funds.

After careful review of claimant’s extensive medical record and the Administrative Law Judge’s personal interaction with claimant at the hearing, this Administrative Law Judge finds that claimant’s exertional and non-exertional impairments render claimant unable to engage in a full range of even sedentary work activities on a regular and continuing basis. 20 CFR 404, Subpart P. Appendix 11, Section 201.00(h). See Social Security Ruling 83-10; *Wilson v Heckler*, 743 F2d 216 (1986). The department has failed to provide vocational evidence which establishes that claimant has the residual functional capacity for substantial gainful activity and that, given claimant’s age, education, and work experience, there are significant numbers of jobs in the national economy which the claimant could perform despite claimant’s limitations. Accordingly, this Administrative Law Judge concludes that claimant is disabled for purposes of the MA program.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that claimant meets the definition of medically disabled under the Medical Assistance program as of January 2007.

Accordingly, the department is ordered to initiate a review of the January 10, 2007 and/or April 30, 2007 application, if it has not already done so, to determine if all other non medical

eligibility criteria are met. The department shall inform claimant and her authorized representative of its determination in writing. Assuming that claimant is otherwise eligible for program benefits, the department shall review claimant's continued eligibility for program benefits in May 2010.
