HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on August 6, 2008.

ISSUE

Whether claimant has established disability for Medical Assistance (MA) and State Disability Assistance (SDA).

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) September 14, 2007, claimant applied for MA, retroactive-MA, and SDA.
- (2) January 3, 2008, the Medical Review Team (MRT) denied claimant's application.
 Department Exhibit A.

- (3) January 7, 2008, the department sent claimant written notice that the application was denied.
 - (4) January 15, 2008, the department received claimant's timely request for hearing.
- (5) April 3, 2008, the State Hearing Review Team (SHRT) denied claimant's application. Department Exhibit B.
- (6) August 6, 2008, the telephone hearing was held. Prior to the close of the record, claimant requested that the record be left open for additional medical evidence. Claimant waived the right to a timely hearing decision. The additional medical evidence was not received and the record closed.
- (7) Claimant asserts disability based on impairments caused by bad back, bad knees, arthritis, carpal tunnel syndrome, headache, asthma, hypertension, and arthritis.
- (8) Claimant testified at hearing. Claimant is 43 years old, 5'8" tall, and weighs 200 pounds. Claimant completed the 7th grade and has poor reading and writing skills. He is able to perform basic math. Claimant's driver's license is revoked. Claimant cares for his needs at home.
 - (9) Claimant's past relevant employment has been as a painter, drywaller, and janitor.
- (10) May 5, 2006, claimant presented to emergency room following a fall from a ladder. Treatment notes indicate claimant has a history significant for Hodgkin lymphoma and past surgical history of laminectomy, appendectomy, and two intra-abdominal surgeries related to Hodgkin lymphoma. In pertinent part, physical exam revealed left wrist pain and tenderness to palpation with decreased range of motion secondary to pain. Patient has an abrasion to his left lower extremity. All other systems are intact. CT scam of the head revealed encephalomalacia involving the left frontal lobe with small lacunar infarct in the left caudate head and no evidence of intracranial hemorrhage. CT scan of the spine revealed a very subtle 6 mm osseous density at

the medial aspect of the left condyle of the occiput at condylar joint of C1 and occiput may represent a small avulsion fracture of the medial aspect of the left occipital; condyle without displacement or dislocation. There is also a small nondisplaced cortical lucency extending from the anterior margin of the left side of the C1 transverse process extending to the anterior margin of the left vertebral foramen. This may represent a nondisplaced fracture at the C1 transverse process. The C1 odontoid and atlantoaxial alignment is maintained. Chest x-ray revealed no evidence of an active cardiopulmonary process. MRI and x-ray revealed no evidence of fracture or dislocation. X-rays of the left wrist revealed question of nondisplaced radial distal fracture. Department Exhibit A, pgs 149-166.

and a narrative report was prepared. Objective physical exam revealed the following: head is normal cephalic. Fundi normal. Neck is supple. No thyromegaly or lymphadenopathy Carotid pulses are normal. No bruit. JVD not evaluated. There is some tenderness to the cervical spine posteriorly. Chest is symmetrical. Breathing is vesicular. No rales. Bilateral rhonchi heard.

Decreased air entry in the bases. Percussion note is hyper-resonant. Heart sounds first and second are normal. No murmur or gallop. Apex beat is in the fifth intercostal space at midclavicularr line There are multiple self inflicted wounds on chest and arms. Abdomen is soft with no palpable mass and no tenderness. Cranial nerves 2-12 are normal. Motor system normal. Plantar are both downgoing. DTRs are 2+. No sensory or motor deficit present. Doctor concludes after examination and review of chart that patient is an alcoholic. He lost his driver's license. He has been in jail three times, each time 30 days, for drinking. He has a history of a car accident under the influence of alcohol in 1986 with brain injury and contusion and also congestion of the larynx. He has had no residual problems from the head injury. The patient complains of neck

pain. Clinical examination was negative for cervical disc disease. He has bilateral carpal tunnel syndrome. He has some lumbar degenerative disc disease without any limitation. He had Hodgkin disease which was operated on in 1992 and is in remission. Department Exhibit A, pgs 168-173.

- (12) September 14, 2006, objective medical testing revealed claimant has Hepatitis C. Department Exhibit A, pg 29.
- (13) On or about September 12, 2006, claimant was brought to hospital after being found unresponsive. Admitting diagnoses were acute respiratory failure secondary to drug overdose, cannot rule out anoxic encephalopathy secondary to respiratory failure; acute renal failure secondary to dehydration; and status post acute upper gastrointestinal bleed. Claimant was admitted and treated. He improved with treatment and was discharged on September 17, 2006. Discharge diagnoses were status post acute respiratory failure and status post chronic obstructive pulmonary disease exacerbation and status post pneumonia; maybe aspiration pneumonia; status post gastrointestinal bleed, stable; status post acute change in mental status secondary to drug overdose; status post acute renal failure and dehydration resolved; history of Hodgkin lymphoma; history of closed head injury and fall; no evidence of fractures; history of alcohol and drug abuse; history of hepatitis. Department Exhibit A, pg 10-11.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative

Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Pursuant to Federal Rule 42 CFR 435.540, the Department of Human Services uses the federal Supplemental Security Income (SSI) policy in determining eligibility for disability under the Medical Assistance program. Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905

A set order is used to determine disability. Current work activity, severity of impairments, residual functional capacity, past work, age, or education and work experience is reviewed. If there is a finding that an individual is disabled or not disabled at any point in the review, there will be no further evaluation. 20 CFR 416.920.

If an individual is working and the work is substantial gainful activity, the individual is not disabled regardless of the medical condition, education and work experience. 20 CFR 416.920(c).

If the impairment or combination of impairments do not significantly limit physical or mental ability to do basic work activities, it is not a severe impairment(s) and disability does not exist. Age, education and work experience will not be considered. 20 CFR 416.920.

Statements about pain or other symptoms do not alone establish disability. There must be medical signs and laboratory findings which demonstrate a medical impairment.... 20 CFR 416.929(a).

- ...Medical reports should include -
- (1) Medical history.
- (2) Clinical findings (such as the results of physical or mental status examinations);
- (3) Laboratory findings (such as blood pressure, X-rays);
- (4) Diagnosis (statement of disease or injury based on its signs and symptoms).... 20 CFR 416.913(b).

In determining disability under the law, the ability to work is measured. An individual's functional capacity for doing basic work activities is evaluated. If an individual has the ability to perform basic work activities without significant limitations, he or she is not considered disabled. 20 CFR 416.994(b)(1)(iv).

Basic work activities are the abilities and aptitudes necessary to do most jobs. Examples of these include --

- (1) Physical functions such as walking, standing, sitting, lifting, pushing, pulling, reaching, carrying, or handling;
- (2) Capacities for seeing, hearing, and speaking;
- (3) Understanding, carrying out, and remembering simple instructions;
- (4) Use of judgment;
- (5) Responding appropriately to supervision, co-workers and usual work situations; and
- (6) Dealing with changes in a routine work setting. 20 CFR 416.921(b).

Medical findings must allow a determination of (1) the nature and limiting effects of your impairment(s) for any period in question; (2) the probable duration of the impairment; and (3) the residual functional capacity to do work-related physical and mental activities. 20 CFR 416.913(d).

Medical evidence may contain medical opinions. Medical opinions are statements from physicians and psychologists or other acceptable medical sources that reflect judgments about the nature and severity of the impairment(s), including your symptoms, diagnosis and prognosis, what an individual can do despite impairment(s), and the physical or mental restrictions. 20 CFR 416.927(a)(2).

All of the evidence relevant to the claim, including medical opinions, is reviewed and findings are made. 20 CFR 416.927(c).

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence, or pace; and ability to tolerate increased mental demands associated with competitive work).... 20 CFR, Part 404, Subpart P, App. 1, 12.00(C).

If an individual fails to cooperate by appearing for a physical or mental examination by a certain date without good cause, there will not be a finding of disability. 20 CFR 416.994(b)(4)(ii).

When determining disability, the federal regulations require that several considerations be analyzed in sequential order. If disability can be ruled out at any step, analysis of the next step is <u>not</u> required. These steps are:

- 1. Does the client perform Substantial Gainful Activity (SGA)? If yes, the client is ineligible for MA. If no, the analysis continues to Step 2. 20 CFR 416.920(b).
- 2. Does the client have a severe impairment that has lasted or is expected to last 12 months or more or result in death? If no, the client is ineligible for MA. If yes, the analysis continues to Step 3. 20 CFR 416.920(c).

- 3. Does the impairment appear on a special listing of impairments or are the client's symptoms, signs, and laboratory findings at least equivalent in severity to the set of medical findings specified for the listed impairment? If no, the analysis continues to Step 4. If yes, MA is approved. 20 CFR 416.290(d).
- 4. Can the client do the former work that he/she performed within the last 15 years? If yes, the client is ineligible for MA. If no, the analysis continues to Step 5. 20 CFR 416.920(e).
- 5. Does the client have the Residual Functional Capacity (RFC) to perform other work according to the guidelines set forth at 20 CFR 404, Subpart P, Appendix 2, Sections 200.00-204.00? If yes, the analysis ends and the client is ineligible for MA. If no, MA is approved. 20 CFR 416.920(f).

At Step 1, claimant is not engaged in substantial gainful activity and so is not disqualified from receiving disability at Step 1.

At Step 2, claimant has a history of closed head injury, injuries from a fall, and injuries from motor vehicle accident. Claimant has history of Hodgkin lymphoma and depresson. The objective medical evidence of record does not indicate that claimant has severe physical and/or cognitive impairments. Finding of Fact 10-13; Department Exhibit A.

At Step 2, the objective medical evidence of record is not sufficient to establish that claimant has severe physical and/or cognitive impairments that have lasted or are expected to last 12 months or more and prevent all employment for a period of 12 months or more.

Accordingly, claimant is disqualified from receiving disability at Step 2.

At Step 3, claimant's impairments do not meet or equal any Social Security Listing.

At Step 4, claimant's past relevant employment has been as a painter, drywaller, and janitor. See discussion at Step 2 above. Finding of Fact 9-13.

At Step 4, the objective medical evidence of record is not sufficient to establish that claimant has severe impairments that have lasted or are expected to last 12 months or more and prevent him from performing the duties required by his past relevant employment for a period of 12 months or more. Accordingly, claimant is disqualified from receiving disability at Step 4.

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated.... 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor.... 20 CFR 416.967.

Sedentary work. Sedentary work involves lifting no more than 10 pounds at a time and occasionally lifting or carrying articles like docket files, ledgers, and small tools. Although a sedentary job is defined as one which involves sitting, a certain amount of walking and standing is often necessary in carrying out job duties. Jobs are sedentary if walking and standing are required occasionally and other sedentary criteria are met. 20 CFR 416.967(a).

Light work. Light work involves lifting no more than 20 pounds at a time with frequent lifting or carrying of objects weighing up to 10 pounds. Even though the weight lifted may be very little, a job is in this category when it requires a good deal of walking or standing, or when it involves sitting most of the time with some pushing and pulling of arm or leg controls....

20 CFR 416.967(b).

Medium work. Medium work involves lifting no more than 50 pounds at a time with frequent lifting or carrying of objects weighing up to 25 pounds. If someone can do medium work, we determine that he or she can also do sedentary and light work. 20 CFR 416.967(c).

Heavy work. Heavy work involves lifting no more than 100 pounds at a time with frequent lifting or carrying of objects weighing up to 50 pounds. If someone can do heavy work, we determine that he or she can also do medium, light, and sedentary work. 20 CFR 416.967(d).

At Step 5, see discussion at Step 2 above. Finding of Fact 10-13.

At Step 5, the objective medical evidence of record is sufficient to establish that claimant is capable of performing work activities. Accordingly, claimant is disqualified from receiving disability at Step 5.

Claimant does not meet the federal statutory requirements to qualify for disability. Accordingly, claimant does not the disability requirements to qualify for Medical Assistance based on disability and the department properly denied his application.

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

2004 PA 344, Sec. 604, establishes the State Disability Assistance program. It reads in part:

Sec. 604 (1) The department shall operate a state disability assistance program. Except as provided in subsection (3), persons eligible for this program shall include needy citizens of the United States or aliens exempt from the Supplemental Security Income citizenship requirement who are at least 18 years of age or emancipated minors meeting one or more of the following requirements:

- (a) Recipient of Supplemental Security Income, Social Security or Medical Assistance due to disability or 65 years of age or older.
- (b) A person with a physical or mental impairment which meets federal SSI disability standards, except that the minimum duration of the disability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.
- (c) A resident of an adult foster care facility, a home for the aged, a county infirmary, or a substance abuse treatment center.
- (d) A person receiving 30-day post-residential substance abuse treatment.
- (e) A person diagnosed as having Acquired Immunodeficiency syndrome (AIDs).
- (f) A person receiving special education services through the local intermediate school district.
- (g) A caretaker of a disabled person as defined in subdivision (a), (b), (e), or (f) above.
- (2) Applicants for and recipients of the State Disability Assistance program shall be considered needy if they:
 - (a) Meet the same asset test as is applied to applicants for the Family Independence Program.
 - (b) Have a monthly budgetable income that is less than the payment standard.
- (3) Except for a person described in subsection (1)(c) or (d), a person is not disabled for purposes of this section if his or her drug addiction or alcoholism is a contributing factor material to the determination of disability. 'Material to the determination of disability' means that, if the person stopped using drugs or alcohol, his or her remaining physical or mental limitations would not be disabling. If his or her remaining physical or mental limitations would be disabling, then the drug addiction or alcoholism is not material to the determination of disability and the person may receive State Disability Assistance. Such a person must actively

participate in a substance abuse treatment program, and the assistance must be paid to a third party or through vendor

payments. For purposes of this section, substance abuse treatment includes receipt of inpatient or outpatient services

or participation in Alcoholics Anonymous or a similar

program. 1995 PA 156, Sec. 605.

(4) A refugee or asylee who loses his or her eligibility for the federal Supplemental Security Income program by virtue of

exceeding the maximum time limit for eligibility as

delineated in Section 402 of Title IV of the Personal Responsibility and Work Opportunity Reconciliation Act of

1996, Public Law 104-193, 8 U.S.C. 1612, and who

otherwise meets the eligibility criteria under this section shall be eligible to receive benefits under the State Disability

Assistance program.

After careful examination of the record and for reasons discussed at Steps 2-5, above, the

Administrative Law Judge decides that claimant does not have severe impairments that prevent

work for 90 days or more. Therefore, claimant does not qualify for SDA based on disability and

the department properly denied his application.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions

of law, decides claimant has not established disability for Medical Assistance and State

Disability Assistance.

Accordingly, the department's action is, hereby, UPHELD.
