# HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a hearing was held on August 14, 2008. The Claimant appeared and testified.

# **ISSUE**

Whether the Department of Human Services (DHS or Department) properly determined

the Claimant is not "disabled" for purposes of the Medical Assistance (MA-P) program and the

State Disability Assistance (SDA) program?

# FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as a material fact:

- 1. On November 16, 2007, the Claimant applied for MA-P and SDA.
- On December 10, 2007, the Medical Review Team (MRT) denied the Claimant's request.

- On January 11, 2008, the Claimant submitted to the Department a request for hearing.
- 4. On April 16, 2008, the State Hearing and Review Team (SHRT) denied the request. A second review by SHRT was made on October 22, 2008, after receipt of additional medical records resulting in a second denial.
- 5. The Claimant is 35 years old.
- 6. The Claimant completed education through 2 years of college.
- 7. The Claimant has employment experience in construction and as a cook.
- 8. The Claimant's limitations have lasted for 12 months or more.
- 9. The Claimant suffers from congenital heart disease.
- 10. The Claimant has significant limitations on physical activities involving sitting, standing, walking, bending, lifting, and stooping.
- 11. A **control**, examination completed by Claimant's physician indicated a stable condition with limitations as follows: lifting up to 20 lbs occasionally, standing/ walking less than 2 hours in an 8-hour day and sitting about 6 hours in an 8-hour day, limited on pushing and pulling and reaching and no use of feet and legs for foot and leg controls. There were no other limitations noted. This same physician indicated a New York heart classification of III indicating the following: marked limitation of physical activity: less than ordinary activity causes fatigue, palpitation, dyspnea or anginal pain.
- 12. An internist exam completed on **a second second**

of exam, had a normal heart rate. This same physician indicated the Claimant's condition was stable. He found the Claimant capable of up to 10 lbs of lifting on an occasional basis, standing/walking less than 2 hours in an 8-hour day and sitting about 6 hours in an 8-hour day, limited on pushing and pulling but no other limitations noted.

#### CONCLUSIONS OF LAW

The Medical Assistance (MA-P) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA-P program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Department conforms to state statute in administering the SDA program.

2000 PA 294, Sec. 604, of the statute states:

Sec. 604. (1) The department shall operate a state disability assistance program. Except as provided in subsection (3), persons eligible for this program shall include needy citizens of the United States or aliens exempted from the supplemental security income citizenship requirement who are at least 18 years of age or emancipated minors meeting 1 or more of the following requirements:

- (a) A recipient of supplemental security income, social security, or medical assistance due to disability or 65 years of age or older.
- (b) A person with a physical or mental impairment which meets federal supplemental security income disability standards, except that the minimum duration of the disability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.

Pursuant to Federal rule 42 CFR 435.540, the Department uses the Federal Supplemental

Security Income (SSI) policy in determining eligibility for disability under the MA-P program.

Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905.

A set order is used to determine disability. Current work activity, severity of

impairments, residual functional capacity, past work, age, or education and work experience are

reviewed. If there is a finding that an individual is disabled or not disabled at any point in the

review, there will be no further evaluation. 20 CFR 416.920.

Medical evidence may contain medical opinions. Medical opinions are statements from physicians and psychologists or other acceptable medical sources that reflect judgments about the nature and severity of the impairment(s), including symptoms, diagnosis and prognosis, what an individual can do despite impairment(s), and the physical or mental restrictions. 20 CFR

416.927(a)(2).

The Administrative Law Judge is responsible for making the determination or decision about whether the statutory definition of disability is met. The Administrative Law Judge reviews all medical findings and other evidence that support a medical source's statement of disability. 20 CFR 416.927(e).

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence, or pace; and ability to tolerate increased mental demands associated with competitive work). 20 CFR, Part 404, Subpart P, Appendix 1, 12.00(C).

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated. 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor. 20 CFR 416.967.

Pursuant to 20 CFR 416.920, a five-step sequential evaluation process is used to determine disability. An individual's current work activity, the severity of the impairment, the residual functional capacity, past work, age, education and work experience are evaluated. If an individual is found disabled or not disabled at any point, no further review is made.

The first step is to determine if an individual is working and if that work is "substantial gainful activity." If the work is substantial gainful activity, an individual is not considered disabled regardless of medical condition, age or other vocational factors. 20 CFR 416.920(b)

Secondly, the individual must have an impairment that must have lasted or must be expected to last for a continuous period of at least 12 months. This is the "durational requirement." 20 CFR 416.909.

The third step in the process is to assess whether the impairment or combination of impairments significantly limits an individual's physical or mental ability to perform basic work activities. If these abilities are not significantly limited, an individual does not have a severe impairment and is, therefore, not disabled. 20 CFR 416.920(c).

In the fourth step of the process the Social Security listing in Appendix 1 is used. If the impairment or combination of impairments meets or is the medical equivalent of a listed impairment as set forth in Appendix 1, the individual is considered disabled. If not, vocational factors are considered. 20 CFR 416.920(d).

In the fifth step, an individual's residual functional capacity is considered in determining whether disability exists. An individual's age, education, work experience and skills are use to evaluate whether an individual has the residual functional capacity to perform work despite limitations. 20 CFR 416.920(e).

Here, the Claimant has satisfied requirement as set forth in steps one, two and three of the sequential evaluation. However, the Claimant's impairments do not meet a listing as set forth in Appendix 1, 20 CFR 416.926. Therefore, vocational factors will be considered to determine the Claimant's residual functional capacity to do relevant work.

In the present case, the Claimant has been diagnosed with a congenital heart disease. The Claimant testified he suffers with chest pain, shortness of breath, dizzy spells, fainting and fatigue. The Claimant indicated on Department Exhibit 1, page 11, that he was capable of lawn care, vacuuming, and washing dishes. The Claimant has a number of symptoms and limitations,

as cited above, as a result of theses conditions. Claimant's treating physician noted that claimant would be able to stand and walk less than 2 hours in an 8-hour day and sit for about 6 hours in an 8-hour day and lift up to 10 lbs occasionally.

This Administrative Law Judge finds that the Claimant has the residual functional capacity to perform work on no more than a sedentary level.

The Claimant is an individual of younger age. 20 CFR 416.963. The Claimant has some college education. 20 CFR 416.964. The Claimant's previous work was unskilled. Federal Rule 20 CFR 404, Subpart P, Appendix 2, contains specific profiles for determining disability based on residual functional capacity and vocational profiles. Under Table I, Rule 201.27, the Claimant is not disabled for the purposes of the Medical Assistance and State Disability Assistance programs.

#### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Claimant is not medically disabled.

Accordingly, the Department decision is hereby UPHELD.
