HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9;

MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a telephone hearing

a hearing was held on August 19, 2009. The Claimant appeared and testified.

ISSUE

Did the Department properly deny the Claimant's application for State Emergency Relief

(SER)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial

evidence on the whole record, finds as material fact:

- 1. On June 26, 2008, the Claimant applied for SER to help with a utility payment.
- 2. On July 2, 2008, the Department denied the Claimant's SER application because the claimant had already received the \$700.00 limit allowed. (Department exhibit 3).
- 3. On June 26, 2008, the Claimant filed a request for a hearing.

CONCLUSIONS OF LAW

The State Emergency Relief (SER) program is established by 2004 PA 344. The SER program is administered pursuant to MCL 400.10, et seq., and by final administrative rules filed with the Secretary of State on October 28, 1993. MAC R 400.7001-400.7049. Department of Human Services (formerly known as the Family Independence Agency) policies are found in the State Emergency Relief Manual (SER).

Under ERM 301 there is a fiscal year cap of \$700.00 for heat and electric. (ERM 301,

p.7).

Here, the department provided evidence that the department had already given the claimant the \$700.00 yearly limit.

I find that the Department correctly denied the SER because the fiscal year limit had been reached.

DECISION AND ORDER

The Administrative Law Judge based on the above findings of fact and conclusions of

law, AFFRIMS the Department's decision.
