HEARING DECISION

This matter is before the undersigned Administrative Law Judge upon pursuant to MCL 400. 9; MCL 400.37 upon claimant's request for a hearing. After due notice a telephone hearing was held on July 23, 2009 and claimant was represented by [REDACTED].

ISSUE

Did the department properly process claimant's March 18, 2008 application for Medicaid (MA)?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. On March 18, 2008 an application was filed on claimant's behalf for Medicaid benefits requesting retroactive coverage to January 2008. (Claimant Exhibit A pp. 4-8)
2. On July 29, 2008 a Medical Program Eligibility Notice was issued regarding a June 6, 2008 application. (Department Exhibit pg. 2)

3. On July 24, 2008 a hearing was requested on claimant's behalf requesting a determination on the March 18, 2008 application.
4. The department testified that no eligibility notice had been issued regarding a March 18, 2008 application.
5. At the hearing, the department agreed to issue a currently dated eligibility notice for the March 18, 2008 application.
6. As a result of this agreement, claimant indicated that he no longer wished to proceed with the hearing.

#### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Under Program Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case claimant is contesting that no eligibility notice was received regarding the determination for the March 18, 2008 MA application. At the hearing the department agreed

to issue a current eligibility notice for the March 18, 2008 MA application. As a result of this agreement, claimant indicated he no longer wished to proceed with the hearing. Since the claimant and the department have come to an agreement it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the department and claimant have come to a settlement regarding claimant's request for a hearing. Therefore it is ORDERED that the department issue a current eligibility notice regarding the March 18, 2008 MA application in accordance with this settlement agreement.
