HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's August 21, 2008 request for a hearing to protest the denial of the claimant's application for Medical Assistance (MA-P) and State Disability Assistance (SDA). After due notice, a telephone hearing was held Tuesday, December 16, 2008. The claimant personally appeared and testified on his own behalf. The record was left open for additional medical information.

ISSUE

Whether the claimant meets the disability criteria for MA-P and SDA?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

(1) On June 23, 2008, the claimant applied for MA-P and SDA benefits without filing an application for retroactive MA-P benefits.

(2) At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Medical records were received and submitted to the State Hearing Review Team (SHRT). SHRT approved claimant's claim of disability on March 4, 2009.

The claimant meets the Social Security approval on with a disability onset date of MA-P is granted June 2008 with retroactive MA-P granted beginning March 2008. SDA is approved per PEM 261. No medical review is required per program guidelines.

CONCLUSIONS OF LAW

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the SHRT determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability, per Program Administrative Manual, Item 600.

Because of the Social Security Administration determination, it is not necessary for the

Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The claimant is eligible for MA-P retroactive to March 2008 and SDA based on his June

23, 2008 application.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions

of law, decides that the claimant meets the definition of medically disabled under MA-P

retroactive to March 2008 and SDA based on his June 23, 2008 application.

Accordingly, if it has not already done so, the department is ORDERED to open an

ongoing Medical Assistance case for the claimant effective the month of the SSI entitlement.
