## HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9;

MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's September 26, 2007 request for a

hearing to protest the department's denial of Medical Assistance, retroactive Medical Assistance,

and State Disability Assistance. After due notice, an in-person hearing was held Tuesday,

April 15, 2008. The claimant personally appeared and testified with his authorized representative,

., and the claimant's mother,

#### **ISSUE**

Whether claimant meets the disability criteria for Medical Assistance, retroactive Medical Assistance, and State Disability Assistance?

#### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

#### 2008-3839/CGF

 On July 9, 2007, the claimant applied for MA-P and SDA with retroactive MA-P to June 2007.

(2) Subsequent to the hearing, the Social Security Administration determined that the claimant met the disability criteria for the SSI and RSDI program effective.

## CONCLUSIONS OF LAW

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if not previously done. The claimant is eligible for retroactive MA-P to April 2006 and SDA based on his July 9, 2007 application.

## DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical Assistance Program retroactive to April 2006 and State Disability Assistance based on the claimant's July 9, 2007 application.

Accordingly, the department is ORDERED to initiate a review of the July 9, 2007 application, if it has not already done so, to determine if all other non-medical eligibility criteria are met.
