HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on April 2, 2008. Claimant personally appeared and testified.

ISSUE

Did the department properly determine claimant is not disabled by Medicaid (MA) and State Disability Assistance (SDA) eligibility standards?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

(1) Claimant is a single, 44-year-old non-smoker/non-drinker with a high school education who filed a disability-based MA/SDA application on July 20, 2007.

(2) Claimant alleges she is completely unable to perform any type of substantial gainful work activity due to debilitating low back pain and self reported migratory arthralgias in her shoulders, elbows, wrists and knees (Client Exhibit A, pg 2).

(3) Claimant stands 5'8" tall and is currently medically obese at 266 pounds (BMI=40.5); she is right hand dominant.

(4) Claimant is a certified nurse's assistant (CNA), and also, she has worked as a phlebotomist, a health unit coordinator and a medical assistant (Department Exhibit #1, pg 16).

(5) Claimant has not been employed since she stopped working for ██████ in March, 2007, taking cars off a ramp via temporary service agency assignment (Department Exhibit #1, pg 3).

(6) Claimant's May, 2007 lumbar spine MRI confirms only mild disc desiccation at L5-S1 with mild disc desiccation and mild facet arthropathy at L4-L5 (Department Exhibit #1, pg 24).

(7) Additionally, this MRI reveals a small central herniation barely effacing claimant's anterior thecal sac; upon axial imaging, this defect appeared more like a protrusion than an actual extrusion with no evidence of central canal stenosis or cauda equine impingement (Department Exhibit #1, pg 24).

(8) Claimant has never been involved in any mental health treatment or counseling and no mental, emotional or cognitive deficits are evidenced by the medical records submitted to date.

(9) Standard analgesics and muscle relaxants have been prescribed for claimant's self reported pain (██████████) (Department Exhibit #1, pg 23).

(10) Other prescription medications include a diuretic (water pill) and [REDACTED] for asymptomatic hypothyroidism secondary to a partial thyroidectomy done in 2002 (Department Exhibit #1, pg 3).

(11) On September 21, 2007, claimant underwent a physical examination at the [REDACTED] [REDACTED] (Client Exhibit C, pgs 7 and 8).

(12) Claimant weighed 290 pounds at that time, and she walked with an antalgic gait but without need of an assistive device (Department Exhibit #1, pg 8)(See also Finding of Fact #3 above).

(13) Claimant's lower extremity strength was 5/5 bilaterally, despite slight pretibial edema (Department Exhibit #1, pg 8)(See also Finding of Fact #10 above).

(14) Claimant demonstrated good lumbar extension and flexion at that time, with pain being reported at the end ranges of motion; additionally, claimant's bilateral hip range of motion tested good and her seated/supine straight leg raising maneuvers were negative bilaterally (Department Exhibit #1, pg 8).

(15) Following a post-hearing review of claimant's exhibits (A-C), the department's State Hearing Review Team (SHRT) continued claimant's disability disallowance based on Med-Voc Rule 202.20, residual ability to perform light work shown.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative

Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Pursuant to Federal Rule 42 CFR 435.540, the Department of Human Services uses the federal Supplemental Security Income (SSI) policy in determining eligibility for disability under the Medical Assistance program. Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905

The SDA program differs from the federal MA regulations in that the durational requirement is 90 days. This means that the person's impairments must meet the SSI disability standards for 90 days in order for that person to be eligible for SDA benefits.

The person claiming a physical or mental disability has the burden to establish it through the use of competent medical evidence from qualified medical sources such as his or her medical history, clinical/laboratory findings, diagnosis/prescribed treatment, prognosis for recovery and/or medical assessment of ability to do work-related activities or ability to reason and to make appropriate mental adjustments, if a mental disability is being alleged, 20 CFR 416.913. An individual's subjective pain complaints are not, in and of themselves, sufficient to establish disability. 20 CFR 416.908 and 20 CFR 416.929. By the same token, a conclusory statement by

a physician or mental health professional that an individual is disabled or blind is not sufficient without supporting medical evidence to establish disability. 20 CFR 416.929.

A set order is used to determine disability. Current work activity, severity of impairments, residual functional capacity, past work, age, or education and work experience is reviewed. If there is a finding that an individual is disabled or not disabled at any point in the review, there will be no further evaluation. 20 CFR 416.920.

If an individual is working and the work is substantial gainful activity, the individual is not disabled regardless of the medical condition, education and work experience. 20 CFR 416.920(c).

If the impairment or combination of impairments do not significantly limit physical or mental ability to do basic work activities, it is not a severe impairment(s) and disability does not exist. Age, education and work experience will not be considered. 20 CFR 416.920.

Statements about pain or other symptoms do not alone establish disability. There must be medical signs and laboratory findings which demonstrate a medical impairment.... 20 CFR 416.929(a).

...Medical reports should include –

- (1) Medical history.
- (2) Clinical findings (such as the results of physical or mental status examinations);
- (3) Laboratory findings (such as blood pressure, X-rays);
- (4) Diagnosis (statement of disease or injury based on its signs and symptoms).... 20 CFR 416.913(b).

In determining disability under the law, the ability to work is measured. An individual's functional capacity for doing basic work activities is evaluated. If an individual has the ability to

perform basic work activities without significant limitations, he or she is not considered disabled.
20 CFR 416.994(b)(1)(iv).

Basic work activities are the abilities and aptitudes necessary to do most jobs. Examples of these include --

- (1) Physical functions such as walking, standing, sitting, lifting, pushing, pulling, reaching, carrying, or handling;
- (2) Capacities for seeing, hearing, and speaking;
- (3) Understanding, carrying out, and remembering simple instructions;
- (4) Use of judgment;
- (5) Responding appropriately to supervision, co-workers and usual work situations; and
- (6) Dealing with changes in a routine work setting. 20 CFR 416.921(b).

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated.... 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the *Dictionary of Occupational Titles*, published by the Department of Labor... 20 CFR 416.967.

Light work. Light work involves lifting no more than 20 pounds at a time with frequent lifting or carrying of objects weighing up to 10 pounds. Even though the weight lifted may be very little, a job is in this category when it requires a good deal of walking or standing, or when

it involves sitting most of the time with some pushing and pulling of arm or leg controls....

20 CFR 416.967(b).

Medical findings must allow a determination of (1) the nature and limiting effects of your impairment(s) for any period in question; (2) the probable duration of the impairment; and (3) the residual functional capacity to do work-related physical and mental activities. 20 CFR 416.913(d).

Medical evidence may contain medical opinions. Medical opinions are statements from physicians and psychologists or other acceptable medical sources that reflect judgments about the nature and severity of the impairment(s), including your symptoms, diagnosis and prognosis, what an individual can do despite impairment(s), and the physical or mental restrictions. 20 CFR 416.927(a)(2).

All of the evidence relevant to the claim, including medical opinions, is reviewed and findings are made. 20 CFR 416.927(c).

A statement by a medical source finding that an individual is "disabled" or "unable to work" does not mean that disability exists for the purposes of the program. 20 CFR 416.927(e).

If an individual fails to follow prescribed treatment which would be expected to restore their ability to engage in substantial gainful activity without good cause, there will not be a finding of disability.... 20 CFR 416.994(b)(4)(iv).

The Administrative Law Judge is responsible for making the determination or decision about whether the statutory definition of disability is met. The Administrative Law Judge reviews all medical findings and other evidence that support a medical source's statement of disability.... 20 CFR 416.927(e).

When determining disability, the federal regulations require that several considerations be analyzed in sequential order. If disability can be ruled out at any step, analysis of the next step is not required. These steps are:

1. Does the client perform Substantial Gainful Activity (SGA)? If yes, the client is ineligible for MA. If no, the analysis continues to Step 2. 20 CFR 416.920(b).
2. Does the client have a severe impairment that has lasted or is expected to last 12 months or more or result in death? If no, the client is ineligible for MA. If yes, the analysis continues to Step 3. 20 CFR 416.920(c).
3. Does the impairment appear on a special listing of impairments or are the client's symptoms, signs, and laboratory findings at least equivalent in severity to the set of medical findings specified for the listed impairment? If no, the analysis continues to Step 4. If yes, MA is approved. 20 CFR 416.290(d).
4. Can the client do the former work that he/she performed within the last 15 years? If yes, the client is ineligible for MA. If no, the analysis continues to Step 5. 20 CFR 416.920(e).
5. Does the client have the Residual Functional Capacity (RFC) to perform other work according to the guidelines set forth at 20 CFR 404, Subpart P, Appendix 2, Sections 200.00-204.00? If yes, the analysis ends and the client is ineligible for MA. If no, MA is approved. 20 CFR 416.920(f).

Claimant is not disqualified from receiving MA/SDA at Step 1, because she has not been gainfully employed since March, 2007 (See Finding of Fact #5 above).

At Step 2, claimant's diagnosed physical impairment (lumbar spine degenerative disc disease) has left her with some slight range of motion limitations and self reported debilitating pain. However, it must be noted no severe mental impairments have been shown, and claimant's minimal degenerative arthritis appears capable of adequate pain management with injections and prescription medications currently being prescribed.

Furthermore, it must be noted that law does not require an applicant to be completely symptom free before a finding of lack of disability can be rendered. In fact, if an applicant's symptoms can be managed to the point where substantial gainful employment can be achieved, a finding of not disabled must be rendered. Nevertheless, claimant's medically managed physical impairment meets the *de minimus* level of severity and duration required for further analysis.

At Step 3, the medical evidence on this record does not support a finding that claimant's only significant, diagnosed impairment is severe enough to meet or equal any specifically listed impairments; consequently, the analysis must continue.

At Step 4, claimant's work experience is so extensive and varied, this Administrative Law Judge cannot fully and fairly decide whether claimant would be capable of returning to any of it. Consequently, ruling any ambiguities in claimant's favor, this Administrative Law Judge will proceed to the very last step of the required sequential evaluation process.

At Step 5, an individual's age, education and previous work experience (vocational factors) must be assessed in light of the documented impairments. Claimant is a younger individual with a high school education and a wide range of unskilled and semi-skilled job experience. Consequently, at Step 5, this Administrative Law Judge law judge finds, from the medical evidence of record, that claimant retains the residual functional capacity to perform at least unskilled light work, as that term is defined above. Claimant's biggest barrier to employability appears to be her lack of recent connection to the competitive work force.

Claimant should be referred to [REDACTED]) for assistance with job placement consistent with her skills, interests and abilities. Claimant is not disabled under the MA/SDA definitions, because she can return to other light work, as directed by Med-Voc Rule 202.20.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides the department properly determined claimant is not disabled by MA/SDA eligibility standards.

Accordingly, the department's action is AFFIRMED.
