HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's request for a hearing to protest the denial of claimant's application for MA-P and SDA with the Michigan DHS. After due notice, a telephone hearing was held on May 13, 2008.

ISSUE

Whether claimant meets the disability criteria for MA and SDA?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On 10/19/07, claimant applied for MA-P and SDA with the Michigan DHS.
- (2) Claimant did not apply for retro MA.
- (3) On 12/13/07, MRT denied.
- (4) On 12/26/07, the department issued notice.

- (5) On 1/11/08, claimant filed a hearing request.
- (6) On 4/9/08, SHRT denied claimant.
- (7) The undersigned Administrative Law Judge was on a scheduled, extended leave of absence from August 1, 2008 until returning full time on February 1, 2009.
- (8) On 5/11/2009, the undersigned Administrative Law Judge received a communication from the local office indicating that pursuant to an SOLQ SSA Response Report, claimant received a fully favorable decision from SSA on an SSI application of 2/22/07. Claimant's disability onset date is identified as 1/25/07. Claimant was eligible effective February, 2007. There are no substantive months left to review herein.

CONCLUSIONS OF LAW

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical Assistance and State Disability Assistance programs as of the 10/19/2007 application date, if otherwise eligible.
