HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's request for a hearing to protest the denial of claimant's MA-P application. After due notice, an in-person evidentiary hearing was held on June 5, 2008. Claimant was represented at the hearing by [REDACTED]

ISSUE

Whether claimant meets the disability criteria for MA-P based upon an amended application date of February 1, 2008?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On 10/15/08, claimant applied for MA-P with the Michigan DHS.
- (2) On 11/13/07, MRT denied.
- (3) On 2/27/07, the department issued notice.
- (4) On 2/12/07, claimant filed a hearing request.

(5) On 4/23/08, SHRT denied claimant.

(6) At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Prior to the submission and issuance to SHRT of new medical documentation, the undersigned Administrative Law Judge received correspondence from [REDACTED] that claimant was approved Social Security pursuant to an alleged amended application date and disability onset date of February 1, 2008. [REDACTED] stipulated that the 2/1/2008 date was applicable to any issues left outstanding with the Michigan DHS.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the MA-P program as of February 1, 2008.
