HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on August 5, 2009. The Claimant was represented by his authorized representative (AR) [REDACTED] of [REDACTED].

ISSUE

Did the Department properly deny the Claimant's Medical Assistance (MA) and retro MA?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

1. On December 16, 2007, the claimant, through his AR, applied for MA and retro MA.
2. The department denied the application for failure to provide verification.
3. On April 15, 2008, the claimant's AR filed a request for a hearing.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Here, the department denied the claimant's application because it had not received verification that the claimant's daughter was an eligible member at the time of application thereby making the claimant ineligible as well.

During the hearing the claimant's AR testified that no verification request had been received and the department was unable to produce same.

**Obtaining Verification**

Since the department was unable to produce evidence that it requested this verification the denial was inappropriate. The department was in error in denying the application based on the claimant's failure to provide verification.

DECISION AND ORDER

The Administrative Law Judge based on the above findings of fact and conclusions of law, REVERSES AND ORDERS the Department to reregister the MA and retro MA applications back to December 18, 2007, and request the verification it needs.
