ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge by authority of MCL 400.9; and MCL 400.37; upon claimant's request for a hearing filed on January 20, 2009. After due notice, a hearing was held on April 30, 2009.

Claimant requested the hearing after department denied his Medicaid (MA) and State Disability Assistance (SDA) application of November 18, 2008. Claimant presented additional medical information at the hearing which was forwarded to department's State Hearing Review Team (SHRT) for additional review.

On May 20, 2009, SHRT requested additional medical information and asked that the department is to contact claimant's treating sources to obtain this information. The Administrative Law Judge conveyed SHRT's request to department's local county office on May 21, 2009. Department's representative advised that the claimant has been approved by department's Medical Review Team (MRT) based on subsequent MA and SDA application he filed on March 3, 2009. MRT approved claimant's benefits back to December, 2008, with only month in question being November, 2008, and claimant did not wish to pursue this month.

On June 16, 2009, this Administrative Law Judge received a Hearing Request Withdrawal signed by the claimant saying he no longer wished to pursue this hearing because he reapplied for benefits on March 3, 2009, and the Medical Review Team approved benefits.

Therefore, it is not necessary for the Administrative Law Judge to decide the matter that was in dispute. Pursuant to MAC R 400.906 and 400.903, claimant's hearing request is HEREBY DISMISSED, because claimant is no longer aggrieved by a department action.
