HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for hearing. After due notice, a telephone hearing was conducted in Detroit, Michigan on May 20, 2009. The Claimant was present and testified. Esther Beneson, FIM and Dwayne Brydie, ES appeared on behalf of the Department.

ISSUE

Whether the Department properly computed Claimant's FAP case without shelter obligation based on Claimant's lack of providing verification?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. Claimant was a FAP recipient.
- The Department issued a negative action notice on 2/18/09 for Claimant's failure to provide shelter obligation verification.

- 3. The Department acknowledged at the hearing that it was in receipt of a shelter verification as of 1/2/09.
- 4. Therefore, the Department agreed that it had issued the 2/18/09 negative action in error and that it would recalculate benefits from 2/18/09 through the present to include the shelter obligation.
- 5. As a result of this agreement, Claimant indicated that she no longer wished to proceed with the hearing decision.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Under Program Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case, the Department has agreed to process the Claimant's FAP case and calculate benefits from 2/18/09 through the present including Claimant's shelter obligation. As a

result of this agreement, Claimant indicated she no longer wished to proceed with the hearing and decision. Since the Claimant and the Department have come to an agreement, it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge, based upon the findings of fact and conclusions of law, finds that the Department and Claimant have come to a settlement regarding claimant's request for a hearing. Therefore, it is ORDERED that the Department shall recalculate FAP benefits from 2/18/09 through the present to include Claimant's shelter obligation and supplement the Claimant for any lost benefits she was otherwise eligible to receive in accordance with department policy.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.
