ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge by authority of MCL 400.9; and MCL 400.37; upon claimant's request for a hearing. After due notice, a hearing was held on June 25, 2009.

During the hearing the Department asserted the hearing request was untimely. The Application Eligibility Notice (DHS-1150) form is dated November 19, 2008. Program Administrative Manual (PAM) 600 specifically states "the AHR or, if none, the client has 90 calendar days from the date of the written notice of case action to request a hearing. The request must be received anywhere in DHS within the 90 days." In this case Claimant's request for hearing was due on, or before, Tuesday, February 17, 2009.

In this case, Claimant's mother is acting as his authorized hearing representative. [REDACTED] testified that: she resides and works in the Washington D.C. area; Claimant sent the notice to her for signature; and she signed the request and mailed it back to the local office. [REDACTED] testified that she does not remember the exact date she mailed the request. The request for hearing is date stamped into the Department Thursday February 19, 2009.

The Department representative testified that normal procedure in the office is for mail room personnel to open, date stamp, and route mail on the day it comes in. In this case, even if some delay occurred and the mail was not opened and date stamped until the day after it arrived, the hearing request would have been one day over the deadline.

The request for hearing was not timely. There is no jurisdiction to hear Claimant's request. Therefore, claimant's hearing request is HEREBY DISMISSED.
