HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9;

and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing

was held on June 10, 2009.

<u>ISSUE</u>

Whether claimant has established disability for purposes of qualifying for Medical

Assistance (MA) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

 October 7, 2008, claimant applied for MA. Claimant submitted medical records for department consideration.

January 2, 2009, the Medical Review Team (MRT) denied claimant's application.Department Exhibit A.

(3) February 11, 2009, the department sent claimant written notice that her application was denied.

(4) February 18, 2009, the department received claimant's timely request for hearing.

(5) April 20, 2009, the State hearing Review Team (SHRT) denied claimant's application. Department B.

(6) June 10, 2009, the telephone hearing was held. Prior to the closing of the record, claimant requested the record be left open for additional medical evidence. Claimant waived the right to a timely hearing decision.

(7) July 31, 2009, after review of all medical records, the SHRT approved claimant's application with disability onset date of July, 2008. SHRT Decision, 7/31/09.

(8) Claimant meets the disability requirements to qualify for MA effective with the earliest retroactive month prior to the application month of October 2008.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Department manuals provide the following policy statements and instructions for caseworkers:

A person meets the disability or blindness factor for a month if he is determined disabled or blind for the month being tested.

42 CFR 435.540, .541 MCL 400.106

In this case, the claimant received a fully favorable decision from the SHRT regarding claimant's disability with disability onset date of July 2008. Claimant meets the disability requirements to qualify for MA effective with the earliest retroactive month prior to the application month of October 2008. Finding of Fact 7-8.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that claimant has established disability for purposes of Medical Assistance effective with the earliest retro active month of application.

Accordingly, the department's action is HEREBY REVERSED. If it has not already done so, the department is to initiate an evaluation of claimant's financial eligibility for Medical Assistance beginning with the earliest retro active month of application. Medical review is set for July 2016.
