HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on January 7, 2009.

<u>ISSUE</u>

Whether claimant has established disability for Medical Assistance (MA) and State Disability Assistance (SDA).

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) May 19, 2008, claimant applied for MA and SDA.
- (2) September 4, 2008, the Medical Review Team (MRT) denied claimant's application. Department Exhibit A.

- (3) September 11, 2008, the department sent claimant written notice that the application was denied.
- (4) September 24, 2008, the department received claimant's timely request for hearing.
- (5) October 22, 2008, the State Hearing Review Team (SHRT) denied claimant's application. Department Exhibit B.
- (6) January 7, 2009, the telephone hearing was held. Prior to the close of the record, claimant submitted additional medical evidence. Claimant waived the right to a timely hearing decision. April 3, 2009, after review of medical evidence, the SHRT again denied claimant's application. SHRT Decision, 4-3-09.
- (7) Claimant asserts disability based on impairments caused by knee pain, back pain, gout, glaucoma, and depression.
- (8) Claimant testified at hearing. Claimant is 54 years old, 6'3" tall, and weighs 180 pounds. Claimant completed high school and is able to read, write, and perform basic math.

 Claimant has a driver's license and is able to drive during the day. Claimant cares for his needs at home.
 - (9) Claimant's past relevant employment has been in factory maintenance work.
- (10) July 23, 2006, claimant underwent an independent physical exam and a narrative report was prepared. Physical exam revealed chest is symmetrical and equal to expansion, lung fields are clear to auscultation and percussion bilaterally, no rales, rhonchi, or wheezes, no retractions. No accessory muscle use is noted, no cyanosis, no cough. Heart has normal sinus rhythm, S1, S2, no rubs, murmur, or gallop. Abdomen is soft, benign, and non distended. Bowel sounds are present. Liver and spleen are not palpable. There are no obvious spinal deformities,

swelling, or muscle spasms noted. Pedal pulses are 2+ bilaterally. There is no calf tenderness, clubbing, edema, varicose veins, brawny erythema, stasis dermatitis, chronic leg ulcers, and no muscle atrophy or joint deformity or enlargement. Examinee was able to get on and off the exam table without difficulty. Gait and stance are normal. Tandem walk, heel walk and toe walk are done without difficulty. Able to squat to 50 percent of the distance and recover. Able to bend to 90 percent of the distance and recover. Grip strength is equal bilaterally. Gross and fine dexterity appear bilaterally intact. Patient is alert, awake, and oriented to person, place and time. Cranial nerves appear to be intact. Examinee has mild twisting of his face to the left side. Impression is claimant has stress-related disorder, hypertension, and history of glaucoma. Range of motion was full in all joints tested. Department Exhibit A, Report, 7-31-06.

- (11) July 31, 2006, claimant underwent an independent psychological assessment and a narrative report was prepared. AXIS I diagnosis is listed as depression. GAF was assessed at 60-65. Mood is somewhat depressed. Affect is somewhat restricted and constricted. Thoughts are spontaneous and logical. He is slightly circumstantial. Rate of speech and loudness were normal. Though content and main themes involve issues of responding to questions. Hallucinations and delusions are denied. Psychotic content was not elicited. He has never been suicidal or homicidal. Sleep and appetite are both reported to be impaired. Guilt and lost themes are present. Claimant was oriented X 3. Memory, information, and judgment appear to be within normal limits. Abstract thinking was impaired. Department Exhibit A, Report, 7-31-06.
- (12) On or about January 7, 2009, claimant's physician completed a Medical Examination Report (DHS-49) following physical exam that took place on January 7, 2009. Current diagnoses are hypertension, glaucoma, gouty arthritis, hyperlipidemia, and peripheral arterial disease. Physical exam revealed a shuffling gait, glaucoma, decreased pedal pulses, pain

and swelling in fingers, toes, and knees; fingers are tender to palpation; depressed affect and impaired concentration. Doctor opines claimant's condition is deteriorating. Claimant is able to occasionally lift less than ten pounds stand and/or walk less than two hours in an eight-hour day, sit less than six hours in an eight-hour day, unable to perform any repetitive actions with upper and lower extremities bilaterally. Doctor notes that claimant has the classical "sausage" distal extremities. Claimant Exhibit A.

(13) Eye exam performed on May 22, 2008, revealed that claimant's left eye is within normal limits and right eye is borderline for glaucoma. Department Exhibit A, pgs 11-18.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual

Pursuant to Federal Rule 42 CFR 435.540, the Department of Human Services uses the federal Supplemental Security Income (SSI) policy in determining eligibility for disability under the Medical Assistance program. Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905

A set order is used to determine disability. Current work activity, severity of impairments, residual functional capacity, past work, age, or education and work experience is

reviewed. If there is a finding that an individual is disabled or not disabled at any point in the review, there will be no further evaluation. 20 CFR 416.920.

If an individual is working and the work is substantial gainful activity, the individual is not disabled regardless of the medical condition, education and work experience. 20 CFR 416.920(c).

If the impairment or combination of impairments do not significantly limit physical or mental ability to do basic work activities, it is not a severe impairment(s) and disability does not exist. Age, education and work experience will not be considered. 20 CFR 416.920.

Statements about pain or other symptoms do not alone establish disability. There must be medical signs and laboratory findings which demonstrate a medical impairment.... 20 CFR 416.929(a).

... Medical reports should include -

- (1) Medical history.
- (2) Clinical findings (such as the results of physical or mental status examinations);
- (3) Laboratory findings (such as blood pressure, X-rays);
- (4) Diagnosis (statement of disease or injury based on its signs and symptoms).... 20 CFR 416.913(b).

In determining disability under the law, the ability to work is measured. An individual's functional capacity for doing basic work activities is evaluated. If an individual has the ability to perform basic work activities without significant limitations, he or she is not considered disabled. 20 CFR 416.994(b)(1)(iv).

Basic work activities are the abilities and aptitudes necessary to do most jobs. Examples of these include --

- (1) Physical functions such as walking, standing, sitting, lifting, pushing, pulling, reaching, carrying, or handling;
- (2) Capacities for seeing, hearing, and speaking;
- (3) Understanding, carrying out, and remembering simple instructions;
- (4) Use of judgment;
- (5) Responding appropriately to supervision, co-workers and usual work situations; and
- (6) Dealing with changes in a routine work setting. 20 CFR 416.921(b).

Medical findings must allow a determination of (1) the nature and limiting effects of your impairment(s) for any period in question; (2) the probable duration of the impairment; and (3) the residual functional capacity to do work-related physical and mental activities. 20 CFR 416.913(d).

Medical evidence may contain medical opinions. Medical opinions are statements from physicians and psychologists or other acceptable medical sources that reflect judgments about the nature and severity of the impairment(s), including your symptoms, diagnosis and prognosis, what an individual can do despite impairment(s), and the physical or mental restrictions. 20 CFR 416.927(a)(2).

All of the evidence relevant to the claim, including medical opinions, is reviewed and findings are made. 20 CFR 416.927(c).

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence, or pace; and ability to tolerate increased mental demands associated with competitive work).... 20 CFR, Part 404, Subpart P, App. 1, 12.00(C).

If an individual fails to cooperate by appearing for a physical or mental examination by a certain date without good cause, there will not be a finding of disability. 20 CFR 416.994(b)(4)(ii).

When determining disability, the federal regulations require that several considerations be analyzed in sequential order. If disability can be ruled out at any step, analysis of the next step is not required. These steps are:

- 1. Does the client perform Substantial Gainful Activity (SGA)? If yes, the client is ineligible for MA. If no, the analysis continues to Step 2. 20 CFR 416.920(b).
- 2. Does the client have a severe impairment that has lasted or is expected to last 12 months or more or result in death? If no, the client is ineligible for MA. If yes, the analysis continues to Step 3. 20 CFR 416.920(c).
- 3. Does the impairment appear on a special listing of impairments or are the client's symptoms, signs, and laboratory findings at least equivalent in severity to the set of medical findings specified for the listed impairment? If no, the analysis continues to Step 4. If yes, MA is approved. 20 CFR 416.290(d).
- 4. Can the client do the former work that he/she performed within the last 15 years? If yes, the client is ineligible for MA. If no, the analysis continues to Step 5. 20 CFR 416.920(e).
- 5. Does the client have the Residual Functional Capacity (RFC) to perform other work according to the guidelines set forth at 20 CFR 404, Subpart P, Appendix 2, Sections 200.00-204.00? If yes, the analysis ends and the client is ineligible for MA. If no, MA is approved. 20 CFR 416.920(f).

At Step 1, claimant is not engaged in substantial gainful activity and so is not disqualified from receiving disability at Step 1.

At Step 2, the objective medical evidence of record indicates that in 2006, claimant's physical condition was within normal limits. In January 2009, claimant suffered from hypertension, glaucoma, gouty arthritis, hyperlipidemia, and peripheral arterial disease. Claimant

walked with a shuffling gait and has swelling and pain in his fingers, toes, and knees. Claimant is unable to perform repetitive actions with either upper and lower extremities bilaterally. In 2006, claimant was found to be depressed with GAF of 60-65 indicative of mild symptoms or difficulties. In 2009, claimant's physician noted that claimant had difficulties with sustained concentration, following simple directions, reading/writing, and social interaction. Claimant Exhibit A, Finding of Fact 10-13.

At Step 2, the objective medical evidence of record is not sufficient to establish that claimant has severe impairments that have lasted or are expected to last 12 months or more and prevent employment at any job for 12 months or more. Therefore, claimant is disqualified from receiving disability at Step 2.

At Step 3, claimant's impairments do not rise to the level necessary to be specifically disabling by law.

At Step 4, claimant's past relevant employment has been in factory maintenance.

Claimant's physical condition would appear to prevent him from performing the duties required by his past relevant employment. See discussion at Step 2 above. Finding of Fact 9-13.

At Step 4, the objective medical evidence of record is sufficient to establish that claimant has functional impairments that prevent claimant, for a period of 12 months or more, from engaging in a full range of duties required by claimant's past relevant employment. Therefore, claimant is not disqualified from receiving disability at Step 4.

The residual functional capacity is what an individual can do despite limitations. All impairments will be considered in addition to ability to meet certain demands of jobs in the national economy. Physical demands, mental demands, sensory requirements and other functions will be evaluated.... 20 CFR 416.945(a).

To determine the physical demands (exertional requirements) of work in the national economy, we classify jobs as sedentary, light, medium and heavy. These terms have the same meaning as they have in the Dictionary of Occupational Titles, published by the Department of Labor.... 20 CFR 416.967.

Sedentary work. Sedentary work involves lifting no more than 10 pounds at a time and occasionally lifting or carrying articles like docket files, ledgers, and small tools. Although a sedentary job is defined as one which involves sitting, a certain amount of walking and standing is often necessary in carrying out job duties. Jobs are sedentary if walking and standing are required occasionally and other sedentary criteria are met. 20 CFR 416.967(a).

Light work. Light work involves lifting no more than 20 pounds at a time with frequent lifting or carrying of objects weighing up to 10 pounds. Even though the weight lifted may be very little, a job is in this category when it requires a good deal of walking or standing, or when it involves sitting most of the time with some pushing and pulling of arm or leg controls....

20 CFR 416.967(b).

Medium work. Medium work involves lifting no more than 50 pounds at a time with frequent lifting or carrying of objects weighing up to 25 pounds. If someone can do medium work, we determine that he or she can also do sedentary and light work. 20 CFR 416.967(c).

Heavy work. Heavy work involves lifting no more than 100 pounds at a time with frequent lifting or carrying of objects weighing up to 50 pounds. If someone can do heavy work, we determine that he or she can also do medium, light, and sedentary work. 20 CFR 416.967(d).

At Step 5, see discussion at Steps 2 and 4 above. Finding of Fact 10-13.

At Step 5, the objective medical evidence of record is sufficient to establish that claimant retains the residual functional capacity to perform sedentary work activities that do not require

repetitive fine manipulation, grasping, reaching, pushing/pulling, or lifting ten pounds or more. Considering claimant's Vocational Profile (closely approaching advanced age, high school education, and history of unskilled work) and relying on Vocational Rule 201.12, claimant is disabled. Therefore, claimant is not disqualified from receiving disability at Step 5.

Claimant meets the federal statutory requirements to qualify for disability. Therefore, claimant meets the disability requirements for Medical Assistance based on disability.

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

2004 PA 344, Sec. 604, establishes the State Disability Assistance program. It reads in part:

Sec. 604 (1) The department shall operate a state disability assistance program. Except as provided in subsection (3), persons eligible for this program shall include needy citizens of the United States or aliens exempt from the Supplemental Security Income citizenship requirement who are at least 18 years of age or emancipated minors meeting one or more of the following requirements:

- (a) Recipient of Supplemental Security Income, Social Security or Medical Assistance due to disability or 65 years of age or older.
- (b) A person with a physical or mental impairment which meets federal SSI disability standards, except that the minimum duration of the disability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.
- (c) A resident of an adult foster care facility, a home for the aged, a county infirmary, or a substance abuse treatment center.

- (d) A person receiving 30-day post-residential substance abuse treatment.
- (e) A person diagnosed as having Acquired Immunodeficiency syndrome (AIDs).
- (f) A person receiving special education services through the local intermediate school district.
- (g) A caretaker of a disabled person as defined in subdivision (a), (b), (e), or (f) above.
- (2) Applicants for and recipients of the State Disability Assistance program shall be considered needy if they:
 - (a) Meet the same asset test as is applied to applicants for the Family Independence Program.
 - (b) Have a monthly budgetable income that is less than the payment standard.
- Except for a person described in subsection (1)(c) or (d), a (3) person is not disabled for purposes of this section if his or her drug addiction or alcoholism is a contributing factor material to the determination of disability. 'Material to the determination of disability' means that, if the person stopped using drugs or alcohol, his or her remaining physical or mental limitations would not be disabling. If his or her remaining physical or mental limitations would be disabling, then the drug addiction or alcoholism is not material to the determination of disability and the person may receive State Disability Assistance. Such a person must actively participate in a substance abuse treatment program, and the assistance must be paid to a third party or through vendor payments. For purposes of this section, substance abuse treatment includes receipt of inpatient or outpatient services or participation in Alcoholics Anonymous or a similar program. 1995 PA 156, Sec. 605.
- (4) A refugee or asylee who loses his or her eligibility for the federal Supplemental Security Income program by virtue of exceeding the maximum time limit for eligibility as delineated in Section 402 of Title IV of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, 8 U.S.C. 1612, and who

otherwise meets the eligibility criteria under this section

shall be eligible to receive benefits under the State Disability

Assistance program.

After careful examination of the record and for reasons discussed at Steps 4 and 5 above,

the Administrative Law Judge decides that claimant does have severe impairments that prevent

work for 90 days or more. Therefore, claimant meets the disability requirement for SDA based

on disability.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions

of law, decides that claimant has established disability for Medical Assistance and State

Disability Assistance.

Accordingly, the department's action is, hereby, REVERSED. The department is to

initiate an evaluation of claimant's financial eligibility for Medical Assistance and State

Disability Assistance in compliance with this Decision and Order and department policy. If

claimant is otherwise eligible, medical review date is set for January 2012.
