DECISION AND ORDER

This matter is before the undersigned Administrative Law Judge (ALJ) pursuant to MCL 400.9 and 42 CFR 431.200 *et seq.*, upon the Appellant's request for a hearing appealing the Department's denial of exception from Medicaid Managed Care Program enrollment.

After due notice, a hearing was held on [REDACTED]. [REDACTED] was represented by his mother, [REDACTED], [REDACTED], represented the Department. [REDACTED], appeared as a witness for the Department.

ISSUE

Does the Appellant meet the requirements for a managed care exception?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. The Appellant is a [REDACTED] Medicaid beneficiary.
2. He is a member of the population required to enroll in a Medicaid Health Plan (MHP). Two requests for a medical exception were made on behalf of the Appellant, the first [REDACTED], and the second [REDACTED].
3. The evidence of record establishes the Appellant has a serious medical condition, arthrogryposis multiplex congenital.
4. The [REDACTED], request for medical exception states the Appellant treats

every 6-12 months. The doctor submitting the request on his behalf is a participating provider, through referral from a health plan.

5. The [REDACTED], request indicates the Appellant treats as needed. It was completed by a doctor who is available to treat the Appellant with a referral from his primary care physician.
6. On [REDACTED], the Appellant's two requests for a managed care exception were denied. The reasons stated in the denial includes that the Appellant is not engaged in frequent and active treatment and that Department records indicate each of the providers who submitted requests are participating providers with a referral from a primary care physician.
7. On [REDACTED] the State Office of Administrative Hearings and Rules for the Department of Community Health received the Appellant's Request for Administrative Hearing.

CONCLUSIONS OF LAW

The Medical Assistance Program is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

On May 30, 1997, the Department was notified of the Health Care Financing Administration's approval of its request for a waiver of certain portions of the Social Security Act to restrict Medicaid beneficiaries' choice to obtain medical services only from specified Qualified Health Plans.

Michigan Public Act 154 of 2005 states, in relevant part:

Sec. 1650 (3) The criteria for medical exceptions to HMO enrollment shall be based on submitted documentation that indicates a recipient has a serious medical condition, and is undergoing active treatment for that condition with a physician who does not participate in one (1) of the HMOs. If the person meets the criteria established by this subsection, the department shall grant an exception to managed care enrollment at least through the current prescribed course of treatment, subject to periodic review of continued eligibility.

MDCH Medicaid Provider Manual, Beneficiary Eligibility Section, October 1, 2005, page 23, states in relevant part:

The intent of a medical exception is to preserve continuity of medical care for a beneficiary who is receiving active treatment for a serious medical condition from an attending physician (M.D. or D.O.) who

would not be available to the beneficiary if the beneficiary was enrolled in a MHP. The medical exception may be granted on a time-limited basis necessary to complete treatment for the serious condition. The medical exception process is available only to a beneficiary who is not yet enrolled in a MHP, or who has been enrolled for less than two months. MHP enrollment would be delayed until one of the following occurs:

- the attending physician completes the current ongoing plan of medical treatment for the patient's serious medical condition, or
- the condition stabilizes and becomes chronic in nature, or
- the physician becomes available to the beneficiary through enrollment in a MHP, whichever occurs first.

If the treating physician can provide service through a MHP that the beneficiary can be enrolled in, then there is no basis for a medical exception to managed care enrollment.

MDCH Medicaid Provider Manual, Beneficiary Eligibility Section, October 1, 2005, page 23, states in relevant part:

Serious Medical Condition

Grave, complex, or life threatening

Manifests symptoms needing timely intervention to prevent complications or permanent impairment.

An acute exacerbation of a chronic condition may be considered serious for the purpose of medical exception.

Chronic Medical Condition

Relatively stable

Requires long term management

Carries little immediate risk to health

Fluctuate over time, but responds to well-known standard medical treatment protocols.

Active treatment

Active treatment is reviewed in regards to intensity of services. The beneficiary is seen regularly, (e.g., monthly or more frequently,) and

The condition requires timely and ongoing assessment because of the severity of symptoms, the treatment, or both

The treatment or therapy is extended over a length of time.

Attending/Treating Physician

The physician (M.D. or D.O.) may be either a primary care doctor or a specialist whose scope of practice enables the interventions necessary to treat the serious condition.

MHP Participating Physician

A physician is considered “participating” in a MHP if he or she is in the MHP provider network or is available on an out-of-network basis with one of the MHPs for which the beneficiary can be enrolled. The physician may not have a contract with the MHP but may have a referral arrangement to treat the plan’s enrollees. If the physician can treat the beneficiary and receive payment from the plan, then the beneficiary would be enrolled in that plan and no medical exception would be allowed.

There is no dispute the Appellant has a serious medical condition as defined in the criteria for medical exception. However, having a serious medical condition is an insufficient basis to grant the exception. All of the criteria must be met. Both of the requests for medical exception evidence the Appellant’s providers participate through the referral process in Medicaid Managed care plans available to the Appellant.

The Appellant’s concerns about use of emergency room services of his choice are not material to the disposition of the case. The criteria for granting a managed care exception does not include considerations surrounding use of emergency room care. The testimony from the Appellant’s mother evidenced concerns based upon hypothetical situations that could or could not arise. While her concerns arise out of past experiences, the medical exception process is not designed to address concerns about the inadequacy of potential emergency room or hospital care that may or may not ever be realized. In short, her testimony did not establish he meets the exception criteria as stated in policy.

For the reasons stated above, the request for exception from Medicaid Managed Care was properly denied.
