HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on May 28, 2009. The Claimant personally appeared and testified.

ISSUE

Did the Department correctly calculate the Claimant's Food Assistance (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) The Claimant was an ongoing FAP recipient. The group size is one.
- (2) On March 11, 2009, the Department ran a recertification FAP budget, showing a FAP benefit of \$31.00. (Department exhibit 1).
- (3) On March 26, 2009, the department ran another FAP budget reflecting shelter verification and showing FAP benefit of \$14.00. (Department exhibit 2).

(7) On April 8, 2009, the Claimant filed a request for a hearing contesting her FAP benefit.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the FAP program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Tables (PRT).

The Claimant questions the amount of the FAP allotment. The claimant has a net income of \$573.00 per month. This was obtained by subtracting the standard deduction of \$135.00 from the gross income of \$708.00.

The amount of a monthly FAP allotment is established by regulations at 7 CFR 273.10. A household of two persons with a net monthly income of \$573.00 was entitled to a monthly FAP grant of \$14.00 per month. (RFT 260, p. 5)

This ALJ finds that the department was correct in its calculation of the claimant's FAP.

DECISION AND ORDER

The Administrative Law Judge based on the above findings of fact and conclusions of law, AFFRIMS the Department's actions finding that the claimant is receiving the correct monthly FAP allotment. The department has agreed to accept new documentation concerning the claimant's rent and adjust the FAP benefit accordingly.
