### **HEARING DECISION**

Whether claimant meets the disability criteria for MA-P?

### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On 9/12/08, claimant applied for MA-P with the Michigan DHS.
- (2) Claimant applied for two months of retro MA.
- (3) On 1/26/09, MRT denied.
- (4) On 1/26/09, the department issued notice.

(5) On 3/17/09, claimant filed a hearing request.

(6) On 5/11/09, SHRT denied claimant.

The undersigned Administrative Law Judge received verification from (7)

showing that the SSA approved claimant RSDI with "disability benefits from Social Security

beginning September 2008."

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security

Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department

of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10,

et seq., and MCL 400.105. Department policies are found in the Program Administrative

Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual

(PRM).

Because of the Social Security Administration determination, it is not necessary for the

Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

**DECISION AND ORDER** 

The Administrative Law Judge, based upon the above findings of fact and conclusions

of law, decides that the claimant meets the definition of medically disabled under the Medical

Assistance program as of September, 2008. If otherwise eligible and if policy permits, the

department may open and/or approve retro MA benefits.
