HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, an in hearing was held on June 22, 2009. The Claimant appeared and testified.

ISSUE

Whether the Department of Human Services (Department) properly determined that the Claimant is not "disabled" for purposes of the Medical Assistance (MA) program?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as a material fact:

1. On January 16, 2009 the Claimant applied for MA-P and SDA.
2. On February 10, 2009 the Department denied the Claimant's application.
3. On March 24, 2009 the Claimant filed a request for hearing regarding the Department's denial of benefits.
4. The Claimant is 64 years old.

5. The Claimant has a PH.D education in French.
6. The Claimant is currently working an adjunct professor.
7. The Claimant suffers from systemic sarcoidosis, asthma, unstable angina.
8. The Claimant's conditions have not prevented employment or activity for 12 months or more.
9. The Claimant's condition has not prevented employment or related activities for 90 days or more.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

In order to receive MA benefits based upon disability or blindness, claimant must be disabled or blind as defined in Title XVI of the Social Security Act (20 R 416.901). The Department, being authorized to make such disability determinations, utilizes the SSI definition of disability when making medical decisions on MA applications. MA-P (disability), also is known as Medicaid, which is a program designated to help public assistance claimants pay their medical expenses.

The law defines disability as the inability to do substantial gainful activity (SGA) by reason of any medically determinable physical or mental impairment which can be expected to

result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months. (20 CFR 416.905).

Because disability must be determined on the basis of medical evidence, Federal regulations have delineated a set order entailing a step sequential process for evaluating physical or mental impairments. When claimant is found either disabled or not disabled at any point in the process, the claimant is not considered further.

The first sequential step to be consider is whether the Claimant can perform Substantial Gainful Activity (SGA) defined in 20 CFR 416.920(b). In this case, the Claimant testified she is currently working and will continue to work. The Claimant teaches two classes in fall and winter and one summer class. The Claimant earns in excess of \$16,940 a year. The Claimant therefore has monthly earnings in excess of \$1400 a month. The Claimant's gross earnings exceed the SGA amount for 2009 of \$980 for non-blind individuals.

It is the finding of the undersigned, based upon the evidence presented that the Claimant is not "disabled" at the first step. The Claimant is substantial gainfully employed.

DECISION AND ORDER

The Administrative Law Judge, based on the findings of fact and conclusions of law, decides that the Claimant is not "disabled" for purposes of the Medical Assistance and State Disability Assistance program.

It is ORDERED; the Department's determination in this matter is AFFIRMED
