HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was conducted on June 18, 2009. The Claimant appeared and testified. Jeffrey Robinson, FIM and Edith Green-Bormar, ES appeared on behalf of the Department.

ISSUE

Whether the Department properly computed the Claimant's Food Assistance ("FAP") benefits effective 3/31/09.

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

- The Claimant was a FAP recipient and an annual FAP review was effective for 4/1/09.
- 2. A food assistance budget was completed on March 31, 2009. (Exhibit 1, pp. 3-4).

- 3. Claimant testified that Claimant has a household group of two (2) people.
- 4. The Claimant testified that the wage verifications upon which the Department based its decision are accurate, including:

- 5. The Department denied Food Assistance Benefits effective 3/31/09 due to excess income. (Exhibit 1, p. 1).
- 6. Claimant objected to the FAP denial and filed this appeal. The Department received the Claimant's Request for Hearing on 5/18/09.

CONCLUSIONS OF LAW

The Food Assistance Program, formerly known as the Food Stamp ("FS") program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations ("CFR"). The Department of Human Services ("DHS"), formally known as the Family Independence Agency, administers the FAP program pursuant to MCL 400.10, *et. seq.* and MAC R 400.3001-3015. Departmental policies are found in the Program Administrative Manual ("PAM"), the Program Eligibility Manual ("PEM"), and the Program Reference Manual ("PRM").

The federal regulations define household income to include all earned and unearned income. 7 CFR 273.9(b). All monthly income must be converted to a nonfluctuating monthly amount. Only 80% of earned income is counted in determining FAP benefits. PEM 550. Under 7 CFR 273.9, as amended, \$135.00 is deducted from the gross income of FAP recipients in

determining FAP grants. A non-categorically eligible Senior/Disabled/Veteran (SDV) FAP group must have income below the net income limits. PEM 550.

In the present case, according to the aforementioned policy on budgeting, for the 1/3/09 budget, Claimant's group had a net monthly gross income of \$3,078.00 from RSDI. As a result, Claimant's group income is over the maximum income limits of 200% of poverty level or \$2,334.00 per month for a group size of two people. RFT 250. Therefore, Claimant does not qualify for FAP benefits. Therefore, the Department established that it acted in accordance with departmental policy in determining the Claimant's FAP denial effective 3/31/09.

It is found that the Department's determination is AFFIRMED.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of

law, finds that the Department properly calculated the Claimant's FAP allotment.

Accordingly, the Department's FAP eligibility determination is AFFIRMED.
