HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's May 20, 2009 request for a hearing to protest the department's denial of his medical review of Medical Assistance and State Disability Assistance. After due notice, a telephone hearing was held Tuesday, August 18, 2009. The claimant personally appeared and testified with his wife, G. T. and case manager and authorized representative,

<u>ISSUE</u>

Whether claimant meets the disability criteria for continued eligibility for Medical Assistance (MA-P) and State Disability Assistance (SDA)?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds a material fact:

- 1. The claimant was a recipient of MA-P and SDA with a medical review required in May 2009.
- 2. On April 17, 2009, the claimant submitted the required documentation for the department to determine continued eligibility for MA-P and SDA.
- 3. Subsequent to the hearing, the Social Security Administration determined that the claimant met the disability criteria for the SSI program with a disability onset date of

CONCLUSIONS OF LAW

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if not previously done. The claimant continues to be eligible for MA-P and SDA retroactive to his medical review that was due May 2009.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law decides that the claimant meets the definition of medically disabled under the Medical Assistance and State Disability Assistance programs retroactive to the date of his medical review of May 2009.

Accordingly, if it has not already done so, the department is ORDERED to open an ongoing Medical Assistance case for the claimant effective the month of the SSI entitlement.
