HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's request for a hearing to protest the denial of claimant's application for MA-P. After due notice, an in-person hearing was held

on August 12, 2009. Claimant was represented at the administrative hearing by

ISSUE

Whether claimant meets the disability criteria for MA-P?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial

evidence on the whole record, finds as material fact:

- (1) On 11/14/08, claimant applied for MA-P with the Michigan DHS.
- (2) Claimant applied for two months of retro MA--September and October, 2008.
- (3) On 1/29/09, MRT denied.

- (4) On 2/12/09, the department issued notice.
- (5) On 5/12/09, claimant filed a hearing request.
- (6) On 7/2/09, SHRT denied claimant.

(7) On 8/12/09, an in person administrative hearing was held. At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Medical records were received and submitted to the State Hearing Review Team (SHRT). On 8/17/09, the submission once again denied claimant.

(8) On 9/25/09, the undersigned Administrative Law Judge received a favorable Social Security Decision by federal ALJ Thomas L. Walters indicating claimant received a fully favorable decision approving claimant for SSI and/or RSDI benefits. Claimant's onset date is identified as September 23, 2008. There are no months left for review herein.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical

Assistance program as of the November, 2008 application date and including two months

of retro MA, if otherwise eligible.
