HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on August 13, 2009. The Claimant personally appeared and testified.

ISSUE

Did the Department properly decrease the claimant's Food Assistance (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. The claimant was an ongoing FAP recipient.
- On July 7, 2009, the department ran a FAP budget that included RSDI income of \$832.00, and a FAP benefit of \$450.00.
- 3. On June 29, 2009, the Claimant filed a request for a hearing.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS)

program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the

federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The

Department of Human Services (formerly known as the Family Independence Agency)

administers the FAP program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015.

Department policies are found in the Program Administrative Manual (PAM), the Program

Eligibility Manual (PEM) and the Program Reference Manual (PRM).

In the instant case the department reduced the claimant's FAP after a FAP budget was

run on July 7, 2009.

The law provides that disposition may be made of a contested case by stipulation or

agreed settlement. MCL 24. 278(2). In the instant case, the parties reached an accord. The

department agreed to accept documentation of allowable expenses and replace lost benefits if

applicable.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and

conclusions of law, finds that the department and claimant have come to an agreement and

ORDERS the department to accept documentation of allowable expenses and replace lost

benefits if applicable.
