HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone hearing was conducted from [REDACTED] on August 18, 2009.

ISSUE

Whether the Department properly terminated Claimant's Food Assistance Program (FAP) case based upon her failure to provide requested verification(s)?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

- (1) On April 6, 2009, Claimant applied for FAP benefits. (Exhibit 1)
- (2) On April 6, 2009, the Department completed a FAP budget which resulted in a FAP allotment of [REDACTED]/mo. (Exhibit 2)

(3) On May 12, 2009, the Department mailed Claimant a Verification Checklist, DHS-3503, with a due date of May 22, 2009. The Department requested that Claimant provide verification for her heat expense, her home rent and her work study. (Exhibit 3)

(4) On May 27, 2009, the Department received verification for Claimant's heat expense, her home rent and her work study. (Exhibit 4)

(5) On June 1, 2009, the Department mailed Claimant a Notice of Case Action informing her that her FAP benefits were cancelled effective May 1, 2009 for failure to provide a month of paystubs from her employment with BAT Conservation and two consecutive ones from U of M, her work study. (Exhibit 5)

(6) On July 2, 2009, the Department received Claimant's hearing request protesting the cancellation of her FAP benefits.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department), administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Departmental policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Bridges Reference Manual (BRM).

Clients must cooperate with the local office in determining initial and ongoing eligibility. This includes the completion of necessary forms. BAM 105, p. 5 Verification means documentation or other evidence to establish the accuracy of the client's verbal or

written statements. BAM 130, p.1 Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as local office option or information regarding an eligibility factor is unclear, inconsistent, incomplete or contradictory. BAM 130, p.1 The Department uses documents, collateral contacts or home calls to verify information. BAM 130, p.1 A collateral contact is a direct contact with a person, organization or agency to verify information from the client. BAM 130, p. 2 When documentation is not available, or clarification is needed, collateral contact may be necessary. BAM 130, p. 2

Clients are allowed 10 calendar days (or other time limit specified in policy) to provide the verifications requested by the Department. BAM 130, p. 4 If the client cannot provide the verification despite a reasonable effort, the time limit should be extended no more than once. BAM 130, p. 4 A negative action notice should be sent when the client indicates a refusal to provide the verification or the time period provided has lapsed and the client has not made a reasonable effort to provide it. BAM 130, p.4

Clients are allowed a reasonable opportunity to resolve any discrepancy between statements and information obtained through another source. BAM 130, p. 6 Disagreements and misunderstandings should be resolved at the lowest possible level to avoid unnecessary hearings. BAM 600, p. 11

In the instant case, Claimant was approved for FAP benefits and provided all requested verifications to the Department. Claimant's FAP benefits were cancelled for not providing verifications that were never requested. I do not find that the Department established that it acted in accordance with policy in terminating Claimant's FAP case based on her failure to provide requested verifications.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, does not find that the Department acted in accordance with policy in terminating Claimant's FAP case based on her failure to provide requested verifications.

Accordingly, the Department's FAP eligibility determination is REVERSED, it is SO ORDERED. The Department shall:

- (1) Reinstatement Claimant's FAP benefits retroactive to the closure date.
- (2) Issue Claimant supplemental benefits she is entitled to, if any.
