HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9;

MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's July 2, 2009 request for a hearing

to protest the department's denial of Medical Assistance and retroactive Medical Assistance.

After due notice, an in-person hearing was held Wednesday, September 16, 2009. The claimant

personally appeared and testified with her authorized representative,

. and family friend, as witnesses.

<u>ISSUE</u>

Whether claimant meets the disability criteria for Medical Assistance and retroactive Medical Assistance?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

 On December 29, 2008, the claimant filed an application for Medical Assistance with retroactive Medical Assistance to September 2008. (2) At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Medical records were received and submitted to the State Hearing Review Team (SHRT). SHRT approved claimant's claim of disability on November 17, 2009.

The claimant is alleging disability due to knee replacement, back and shoulder pain, and depression. She is 51 years old with 12 years of education and a history of working as a cook and kitchen manager. The claimant received a Social Security approval for RSDI and SSI with a disability onset date of **Constant of Security**. Per the Social Security Administration approval, Medical Assistance is granted as of December 2008 with retroactive Medical Assistance beginning September 2008. No medical review pre program guidelines.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the SHRT determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability, per Program Administrative Manual, Item 600.

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The claimant is eligible for Medical Assistance retroactive to March 2007.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of

law, decides that the claimant meets the definition of medically disabled under Medical

Assistance retroactive to March 2007.

Accordingly, if it has not already done so, the department is ORDERED to open an

ongoing Medical Assistance case for the claimant effective the month of the SSI entitlement.
