HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on March 29, 2010. Claimant appeared and testified. Claimant was represented by her [REDACTED]

ISSUE

Did the Department of Human Services (DHS or department) properly terminate claimant's Medical Assistance (MA) case?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1) Claimant was an ongoing recipient of MA benefits.
- 2) On April 18, 2009, the department terminated claimant's MA benefits.

- 3) On June 30, 2009, claimant filed a hearing request to protest the department's determination.
- 4) In July of 2009, claimant filed a new application for benefits.
- 5) Claimant's MA was reopened effective July 1, 2009.
- 6) At the time of the hearing, claimant sought MA coverage for the months of May and June of 2009.
- 7) At the hearing, the parties reached an accord. The department agreed to initiate consideration of claimant's eligibility for retroactive MA for the months of May and June of 2009. The department agreed to notify claimant and her authorized representative of its determination in writing.
- 8) Claimant and her authorized representative indicated satisfaction with the department's plan of action.

CONCLUSIONS OF LAW


The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2). In this case, the parties reached an accord. The department agreed to initiate consideration of claimant's eligibility for retroactive MA for the months of May and June of 2009. The department further agreed to notify claimant and her authorized

representative of its determination in writing. Claimant and her authorized representative indicated satisfaction with the department's plan of action.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department of Human Services shall initiate consideration of claimant's eligibility for retroactive Medical Assistance for the months of May and June of 2009. The department will notify claimant and her authorized representative of its determination in writing.
