ORDER DISMISSING HEARING

This matter is before the undersigned Administrative Law Judge upon pursuant to MCL 400. 9; MCL 400.37 upon claimant's request for a hearing. After due notice a telephone hearing was held on March 19, 2007 and claimant was not represented.

The regulations governing hearing and appeals for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code. MAC R 400.901-.951. MAC R 400. 903 reads in part: An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance is denied or is not acted upon with reasonable promptness, and to any recipient who is aggrieved by a department action resulting in suspension, reduction, discontinuance, or termination of assistance.

In the present case, claimant filed a request for hearing. The department however has not currently taken a negative action or failed to act in a timely manner regarding benefits or services to the claimant. Claimant testified that the department has since provided benefits requested. Claimant complains of the professionalism of department personnel. However this Administrative Law Judge has no jurisdiction for such matters.

Therefore this hearing is dismissed pursuant to MAC R 400.903(1). PAM 600.
