#### HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was conducted on October 7, 2009. The Claimant appeared and testified. Nisan Fortson, ES appeared on behalf of the Department.

#### <u>ISSUE</u>

Whether the Department properly computed the Claimant's Food Assistance ("FAP") benefits on Claimant's 6/25/09 application?

### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds a material fact:

- 1. The Claimant applied for FAP benefits on 6/25/09.
- The Department prepared a FAP budget in June of 2006 which resulted in a \$16.00 FAP benefit award. (Exhibit 1, pp. 1-8).
- 3. The Claimant testified that she lives alone.

- 4. The Claimant testified that she receives \$638.00 every two weeks in unemployment compensation benefits.
- 5. The Claimant testified that her rent at the time of the budget was \$550.00/month.
- 6. The Claimant testified she is responsible for heat and electricity and telephone.
- 7. The Claimant receives unemployment compensation in the amount of \$638.00 every two weeks.
- 8. Claimant objected to the FAP calculation and filed this appeal. The Department received the Claimant's Request for Hearing on August 4, 2009.

#### CONCLUSIONS OF LAW

The Food Assistance Program, formerly known as the Food Stamp ("FS") program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations ("CFR"). The Department of Human Services ("DHS"), formally known as the Family Independence Agency, administers the FAP program pursuant to MCL 400.10, *et. seq.* and MAC R 400.3001-3015. Departmental policies are found in the Program Administrative Manual ("PAM"), the Program Eligibility Manual ("PEM"), and the Program Reference Manual ("PRM").

The federal regulations define household income to include unemployment compensation benefits. 7 CFR 273.9(b). All monthly income must be converted to a nonfluctuating monthly amount. Only 80% of earned income is counted in determining FAP benefits. PEM 550. Under 7 CFR 273.9, as amended, \$135.00 is deducted from the gross income of FAP recipients in determining FAP grants. Under 7 CFR 273.9 deductions for excess shelter are also made. PEM 554. Household groups that do not have a Senior/Disabled veteran (SDV) member are given a standard deduction of \$35.00/month for medical expenses. <u>Id.</u> There is a standard heat and utility deduction as well as a standard deduction for telephone bills. <u>Id.</u> The standard

deductions are a set amount that is applied regardless of the actual expenses incurred by the

Claimant.

In the present case, according to the aforementioned policy on budgeting, Claimant has a

net monthly income of \$790.00. This was obtained by subtracting the standard deduction of

\$135.00 and the maximum excess shelter amount of \$446.00 from the gross income of \$1371.00.

The amount of food assistance allotment is established by regulations at 7 CFR 273.10. A

household of two people with a net monthly income of \$790.00 is entitled to a monthly FAP

grant of \$16.00 per month. RFT 260.

Claimant testified at the hearing regarding additional expenditures such as medical bills

and court fees. Unfortunately, these items are not considered in the federal guidelines for

awarding benefits. 7 CFR 273. The undersigned appreciates that economic times are difficult,

but finds that the Department properly calculated benefits.

Based upon the foregoing facts and relevant law, it is found that the Department's

determination is AFFIRMED.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of

law, finds that the Department properly calculated the Claimant's FAP allotment.

Accordingly, the Department's FAP eligibility determination is AFFIRMED.
