HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on February 18, 2010. Claimant was represented by [REDACTED].

ISSUE

Did the Department of Human Services (DHS or department) properly process claimant's application for Medical Assistance (MA-P) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1) On January 28, 2009, an application was filed on claimant's behalf for MA-P benefits. The application requested MA-P retroactive to October of 2008.
- 2) On July 22, 2009, a hearing request was filed on claimant's behalf to protest the department's failure to provide requested benefits.

- 3) At the hearing, the parties reached an accord. The department agreed to initiate consideration of claimant's January 28, 2009, application for MA-P. The department agreed to notify claimant and his authorized representative of its determination in writing.
- 4) Claimant's authorized representative indicated satisfaction with the department's plan of action.

CONCLUSIONS OF LAW


The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24.278(2). In this case, the parties reached an accord. The department agreed to initiate reconsideration of the January 28, 2009, application for MA-P benefits retroactive to October of 2008. The department further agreed to notify claimant and his authorized representative of its determination in writing. Claimant's authorized representative indicated satisfaction with the department's plan of action.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department of Human Services shall initiate consideration of claimant's

January 28, 2009, application for Medical Assistance. The department shall notify claimant and his authorized representative of its determination in writing.
