HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's request for a hearing to protest the denial of claimant's application for MA and SDA. After due notice, a telephone hearing was held.

<u>ISSUE</u>

Whether claimant meets the continuing disability criteria for Medical Assistance (MA) and State Disability Assistance (SDA) at review?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) In July, 2008, claimant's MA-P and SDA cases were reviewed with the Michigan DHS.
- (2) There is no issue herein regarding retro MA.
- (3) On 7/17/08, MRT denied claimant as though claimant's case was a new application. At issue herein is a review case not a new application.
- (4) On 8/22/08, the DHS issued notice.

- (5) On 9/2/08, claimant filed a timely hearing request. The department reinstated the action pending the outcome of the hearing.
- (6) On 10/10/08, SHRT failed to apply the correct review standard and instead treated the issue as a new application.
- (7) At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Medical records were received and submitted to the State Hearing Review Team (SHRT), and on 2/11/2009, SHRT once again applied the incorrect standard.
- (8) Subsequent to the hearing, the Social Security Administration determined that the claimant met the disability criteria for the programs with a disability onset date of 1/1/2004.
- (9) On 9/7/2010, the undersigned Administrative Law Judge received an SOLQ SSA Response Report indicating claimant was approved disability benefits by SSA. Claimant's onset date is identified as 1/1/2004. The SOLQ code indicates that claimant was terminated.

CONCLUSIONS OF LAW

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if required by DHS policy and procedure.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the MA and SDA programs as of the 7/17/08 review date, if otherwise eligible, and as permitted under policy and procedure.

The department shall review this case in accordance with its usual policy and procedure.

It is noted that the verification from Social Security indicates that claimant is in a payment status code of: "T51" which indicates that claimant was terminated. The department is ordered to examine income and asset eligibility with regards to the termination date as indicated on the Social Security SOLQ. If necessary, the department is ordered to obtain any required verification(s).
