HEARING DECISION

ISSUE

Did the Department properly deny the Claimant's Medical Assistance (MA) and Retroactive Medical assistance applications?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. On July 26, 2008, the Claimant applied for MA and retro MA.
- 2. On September 12, 2008, the Department denied the MA and retro MA applications.
- 3. On September 16, 2008, the Claimant, through his PR. requested a hearing.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security

Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department

of Human Services (formerly known as the Family Independence Agency) administers the MA

program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in

the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the

Program Reference Manual (PRM).

Here, the Department requested information concerning the Claimant's MA case and sent

a verification form to both the Claimant and his PR, with a due date of August 11, 2008.

The law provides that disposition may be made of a contested case by stipulation or

agreed settlement. MCL 24. 278(2). In the instant case, the parties reached an accord. The

Department agreed to re-register the MA as of July 26, 2008, with retroactive MA to April, 2008.

DECISION AND ORDER

The Administrative Law Judge based on the above findings of fact and conclusions of

law, REVERSES AND ORDERS the Department to re-register the MA as of July 26, 2008, with

retroactive MA to April, 2008.
