HEARING DECISION

This matter is before the undersigned Administrative Law Judge upon pursuant to MCL 400.9; MCL 400.37 upon claimant's request for a hearing. After due notice a telephone hearing was held on July 30, 2009 and claimant was not represented.

ISSUE

Did the department properly determine claimant's deductible amount?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. The claimant was an ongoing MA recipient in a household of one person.
2. Claimant had income consisting of RSDI benefits. (Exhibit p 4)
3. The department determined that claimant had a net income of \$945 per month resulting in a Medicaid deductible of \$550 per month. (Exhibit p.3)
4. Claimant requested a hearing contesting the deductible amount on October 30, 2008.

5. At the hearing, the department agreed to accept past medical bills from claimant which will be used to re-determine eligibility for the appropriate months.
6. As a result of this agreement claimant, indicated that he no longer wished to proceed with the hearing.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Under Program Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case claimant was contesting the deductible amount for his MA benefits. At the hearing the department agreed to accept past medical bills from claimant which will be used to re-determine eligibility for the appropriate months. As a result of this agreement, claimant indicated he no longer wished to proceed with the hearing. Since the claimant and the department have come to an agreement it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the department and claimant have come to a settlement regarding claimant's request for a hearing. Therefore, it is ORDERED that upon receipt of past medical bills from claimant, the department will re-determine eligibility for the appropriate months in accordance with this settlement agreement.
