## **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on July 22, 2009.

#### ISSUES

- (1) Was entry into the U.S. five years earlier than date of Medicaid application?
- (2) Are exceptions to DHS policy requirements allowed by ALJs?

#### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

(1) Negative action: Medicaid application on September 23, 2008 and was denied on October 22, 2008 based on claimant not entering the U.S. five years earlier per PEM 225; claimant agrees that DHS correctly denied her Medicaid application based on DHS policy requirements, but wants an exception based on her medical condition.

#### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Facts above are undisputed.

#### Issue 1

Based on the undisputed facts above, the DHS correctly denied the claimant's application, as a matter of law.

### Issue 2

Administrative law judges have no authority to make decisions on constitutional grounds, overrule statutes, overrule promulgated regulations or overrule or make exceptions to the department policy set out in the program manuals. Delegation of Hearing Authority, August 9, 2002, per PA 1939, Section 9, Act 280.

Therefore, as a matter of law, this ALJ has no legal authority to grant the claimant's requested exception to DHS policy requirements.

#### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that:

- (1) Medicaid denial was correctly determined, and
- (2) Exceptions to DHS policy requirements are not allowed by ALJs.

Accordingly:

#### 2009-6849/WAS

- (1) Medicaid denial is UPHELD and,
- (2) Hearing request is DISMISSED.
