HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37 upon claimant's request for a hearing. After due notice, an in-person hearing was held on October 6, 2009.

<u>ISSUE</u>

Whether the department properly determined claimant's eligibility for Medical Assistance (MA).

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On or about October 30, 2008, the department sent claimant written notice that his MA would terminate due to excess assets.
- (2) On or about November 5, 2008, the department received a timely request for hearing.
- (3) After receipt of hearing request, the department reviewed its proposed action and rescinded the proposed termination of benefits.
 - (4) Claimant continues to be eligible for MA without a break in coverage.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

At hearing, the department testified its proposed termination of claimant's MA benefits was rescinded. According to department testimony and documentary evidence, claimant has received MA without a break in coverage. Claimant continues to receive MA. Finding of Fact 1-4; Computer Printout.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides after careful examination of the record, that the department rescinded its

proposed negative action and there is no longer a matter in controversy within the Administrative Law Judge's jurisdiction.

Accordingly, the matter is, hereby, DISMISSED.
