HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on March 4, 2009.

ISSUE

Was the claimant's FAP allotment computed and allocated correctly?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

(1) Claimant was receiving a Food Assistance Program (FAP) allotment budget of [REDACTED]

(2) On 12-5-08, [REDACTED] applied for FAP benefits.

(3) In his application, [REDACTED] stated that he lived with claimant and that they buy and prepare food together.

(4) [REDACTED] was added to claimant's member group.

(5) [REDACTED] RSDI benefit was added to claimant's unearned income.

(6) This resulted in a lowering of the group FAP budget to [REDACTED]

(7) Claimant filed for hearing on 12-22-09, alleging that DHS incorrectly computed her budget, and therefore, allocated the wrong amount of FAP benefits.

### CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

When determining eligibility for FAP benefits, the household's total income must be evaluated. All earned and unearned income of each household member must be included unless specifically excluded. PEM, Item 500. A standard deduction from income of \$135 is allowed for each household. Certain non-reimbursable medical expenses above \$35 a month may be deducted for senior/disabled/veteran group members. Another deduction from income is provided if monthly shelter costs are in excess of 50% of the household's income after all of the other deductions have been allowed, up to a maximum of \$300 for non-senior/disabled/veteran households. PEM, Items 500 and 554; RFT 255; 7 CFR 273.2.

In this case, the Administrative Law Judge has reviewed the FAP budget and finds that the department properly computed the claimant's net income. The gross RSDI benefit amount must be counted as unearned income, which is [REDACTED] in the current case, after counting claimant's benefits of [REDACTED] and [REDACTED] benefits of [REDACTED] PEM 500. These amounts were verified by an SOLQ, presented as Department Exhibit 4. Furthermore, the Department presented proof, and the claimant verified that [REDACTED] is a legitimate member of the FAP group. The federal regulations at 7 CFR 273.10 provide standards for the amount of a household's benefits. The department in compliance with the federal regulations has prepared issuance tables which are set forth at Program Reference Manual, Table 260. The issuance table provides that a household with household size and net income of the claimant is eligible for an FAP allotment of [REDACTED]. The Administrative Law Judge has reviewed the budget and found no errors. Claimant herself was unable to point out specifically what parts of the budget she felt were in error. Therefore, the undersigned finds that the FAP allotment was computed correctly.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department's decision to decrease the claimant's FAP allotment to [REDACTED] was correct.

Accordingly, the Department's decision is AFFIRMED.
