HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37 upon Claimant's request for a hearing. After due notice, a hearing was held on July 8, 2009. Claimant appeared and personally testified. An eligibility specialist and a family independence manager represented the Department.

ISSUE

Did the Department properly determine to change Claimant's Medical Assistance (MA) case to a spend-down/deductible status after a review of her case?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant is a recipient of MA benefits.
- (2) Upon completing a review of her case in November 2008, the Department learned that her budget had been incorrectly calculated because Claimants not a SDC, 503 individual. As a result, Claimant received full Medicaid coverage.

- (3) In November 2008, the Department determined that Claimant's monthly RSDI income was \$1,081 and her monthly child support income was \$266. The Department calculated her MA budget based on her RSDI and child support income, resulting in a determination that she was eligible for a spend-down/deductible of \$589 effective December 2008.
- (4) Claimant disagreed with the Department determination on the grounds that she needs full medical coverage.
- (5) Claimant requested a hearing on November 25, 2008.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies for FAP and MA are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

DEPARTMENT POLICY

All Programs

This item discusses income for:

- Family Independence Program (FIP)
- State Disability Assistance (SDA)
- Refugee Assistance Program (RAP) which if policy differs is divided into:
 - Refugee Assistance Program Cash (RAPC)
 - Refugee Assistance Program Medical (RAPM)
- Child Development and Care (CDC)

Note: Applies to all CDC Income Eligible groups

- Medicaid (MA) which, if policy differs, is divided into:
 - FIP-related MA

- SSI-related MA
- Specific MA categories

- Adult Medical Program (AMP)
- TMA-Plus (TMAP)
- Food Assistance Program (FAP)

The phrase “All Programs” in this item means all the programs listed above.

The group composition and program budgeting items specify whose income to count. The program budgeting items also contain program specific income deductions and disregards.

Income means benefits or payments received by an individual which is measured in money. It includes money an individual owns even if NOT paid directly such as income paid to a representative.

Earned income means income received from another person or organization or from self-employment for duties that were performed for remuneration or profit. Unearned income means all income that is NOT earned income. The item specifies whether the income is earned or unearned.

The amount of income counted may be more than the amount a person actually receives because it is the amount before any deductions including deductions for taxes and garnishments. The amount before any deductions is called the **gross** amount.

Exception: The amount of self-employment income before any deductions is called **total proceeds**. The **gross** amount of self-employment income means the amount after deducting allowable expenses from total proceeds, but before any other deductions.

Income remaining after applying the policy in this item is called **countable**.

Count all income that is NOT specifically excluded. (PEM 500 p. 1-2)

Under PEM 500, RSDI income is countable income for determining MA eligibility. In this case, the Department calculated Claimant’s MA budget for December 2008 and based on a combined monthly income of \$1,347. Claimant does not dispute the accuracy of her income at the time of this budget. Because Claimant has a variety of health issues and incurs significant medical expenses, she argues that she needs full medical coverage. The evidence at this hearing did not establish that the Department

erred in changing Claimant MA case to a \$589 spend-down/deductible status as of December 2008.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department properly applied a \$589 spend-down/deductible status to Claimant's MA case, effective December 2008.

Accordingly, the Department's decision is AFFIRMED.
