HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held.

<u>ISSUE</u>

Did the Department of Human Services (DHS) properly deny claimant's Medical Assistance (MA-P) and State Disability Assistance (SDA) application?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- On October 6, 2008, claimant applied forMA-P and SDA with the Michigan DHS.
- Claimant applied for three months of retro MA.
- 3. On November 10, 2008, the MRT denied.
- 4. On November 17, 2008, the DHS issued notice.
- 5. On December 1, 2008, claimant filed a hearing request.
- 6. At the administrative hearing, claimant testified that she had applied for SSI with the Social Security Administration (SSA) approximately in September, 2008. Claimant further testified that she did not appeal the denial. Claimant testified under oath that she is alleging at the time of the

- administrative hearing herein and at the time of the SSI denial with SSA the same impairments.
- 7. Claimant has been denied SSI by the Social Security Administration (SSA). Claimant has had a final determination by SSA. None of the exceptions apply.
- 8. On January 16, 2009, the State Hearing Review Team (SHRT) denied claimant. Pursuant to claimant's request to hold the record open for the submission of new and additional medical documentation, on February 17, 2010, SHRT once again denied claimant.
- 9. As of the date of application, claimant was a 54-year-old female standing 5'2" tall and weighing 223 pounds. Claimant's BMI Index is 40.8 classifying claimant as morbidly obese under the medical chart.
- 10. Claimant does not have an alcohol/drug abuse problem or history. Claimant smokes approximately one pack of cigarettes per day. Claimant has a nicotine addiction.
- 11. Claimant has a driver's license and can drive an automobile.
- 12. As of the date of the administrative hearing, claimant was not working. Claimant's work history is unskilled.
- 13. The January 16, 2009, and subsequent February 27, 2010 SHRT decisions are adopted and incorporated by reference herein.
- 14. On March 23, 2011, the undersigned Administrative Law Judge received an SOLQ showing claimant has reapplied on August 23, 2010.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Statutory authority for the SDA program states in part:

(b) A person with a physical or mental impairment which meets federal SSI disability standards, except that the minimum duration of the disability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.

Prior to any substantive review, jurisdiction is paramount. Applicable to the case herein, policy states:

Final SSI Disability Determination

SSA's determination that disability or blindness does **not** exist for SSI purposes is **final** for MA if:

- . The determination was made after 1/1/90, and
- . No further appeals may be made at SSA, or
- . The client failed to file an appeal at any step within SSA's 60-day limit, **and**
- . The client is **not** claiming:
 - .. A totally different disabling condition than the condition SSA based its determination on, **or**
 - .. An additional impairment(s) or change or deterioration in his condition that SSA has **not** made a determination on.

Eligibility for MA based on disability or blindness does **not** exist once SSA's determination is **final**. PEM, Item 260, pp. 2-3.

Relevant federal regulations are found at 42 CFR Part 435. These regulations provide: "An SSA disability determination is binding on an agency until the determination is changed by the SSA." 42 CFR 435.541(a)(b)(i). These regulations further provide: "If the SSA determination is changed, the new determination is also binding on the agency." 42 CFR 435.541(a)(b)(ii).

In this case, there is apparently no dispute relative to the facts. Claimant's claim was considered by SSA and benefits denied. The determination was final. Claimant is alleging the same impairments. None of the exceptions apply. As noted in the Findings of Fact, claimant subsequent to this administrative hearing reapplied with SSA on August 23, 2010. However, a new application is not retroactive with regards to

jurisdiction to the instant case. In the instant case, claimant had a final SSA determination. Under 42 CFR 435.541(a)(iii), there was no jurisdiction at the time of the administrative hearing, and thus, the denial is upheld.

For these reasons, under the above-cited policy and federal law, this Administrative Law Judge has no jurisdiction to proceed with a substantive review. The department's denial must be upheld.

As noted above, should the SSA change its determination, then the new determination would also be binding on the DHS.

In the alternative, should the sequential analysis be applied, the undersigned Administrative Law Judge would concur with the findings and conclusions of the SHRT decisions in finding claimant not disabled under federal law and state policy.

If claimant alleges the exceptions, claimant may reapply with DHS.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the department's actions were correct.

Accordingly, the department's determination in this matter is upheld.
