HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on March 19, 2009. The Claimant personally appeared and testified.

ISSUE

Did the Department properly calculate the Claimant's Food Assistance (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

1. On January 22, 2009, the claimant re-applied for FAP.
2. On January 22, 2009, the claimant reported starting a new job.
3. On February 5, 2009, the claimant reported and verified that her employment had ended.
4. On February 5, 2009, the claimant filed a request for a hearing.

5. On February 9, 2009, the department removed the prospective income from the claimant's FAP budget.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the FAP program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Claimant states that she never received any income from the reported employment. She began training on February 2, 2009, and never received any income.

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24 278(2) In the instant case, the parties reached an accord. The Department agreed to refigure the claimant's February FAP benefits and replace any lost benefits if appropriate.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, REVERSES AND ORDERS the Department refigure the claimant's February FAP benefits and replace any lost benefits if appropriate.
