HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was conducted on September 21, 2009. The Claimant appeared and testified. Sharon Nunley, FIS, appeared on behalf of the Department.

ISSUE

Whether the Department denied the Claimant's Food Assistance ("FAP") benefits.

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds a material fact:

1. The Claimant is a FAP recipient.
2. Claimant testified that her FAP benefits had been denied at one point under a previous case worker.
3. Claimant testified that she has not suffered any loss of benefits.

4. Claimant filed this appeal. The Department received the Claimant's Request for Hearing on August 3, 2009.

#### CONCLUSIONS OF LAW

The Food Assistance Program, formerly known as the Food Stamp ("FS") program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations ("CFR"). The Department of Human Services ("DHS"), formally known as the Family Independence Agency, administers the FAP program pursuant to MCL 400.10, *et. seq.* and MAC R 400.3001-3015. Departmental policies are found in the Program Administrative Manual ("PAM"), the Program Eligibility Manual ("PEM"), and the Program Reference Manual ("PRM").


The federal regulations define household income to include all earned income. 7 CFR 273.9(b). All monthly income must be converted to a nonfluctuating monthly amount. Only 80% of earned income is counted in determining FAP benefits. PEM 550. Under 7 CFR 273.9, as amended, a standard deduction (\$135) is deducted from the gross income of FAP recipients in determining FAP grants. Under 7 CFR 273.9 deductions for excess shelter are also made. PEM 554. There is a standard heat and utility deduction as well as a standard deduction for telephone bills. Id.

In the present case, Claimant's benefits were denied at one point by a previous case worker. However, the Claimant testified that she did not suffer any loss of benefits. Based upon the foregoing facts and relevant law, therefore, this hearing request is dismissed with prejudice.

#### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds that the Department has already corrected its error and Claimant is not suffering any loss of benefits.

Accordingly, this hearing request is dismissed with prejudice.
