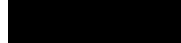

HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on January 21, 2009. The Claimant personally appeared and testified.

ISSUE

Did the Department properly compute the Claimant's Family Independence Program (FIP), and Food Assistance (FAP), benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

1. On August 29, 2008, the Claimant applied for FIP and FAP.
2. On November 10, 2008, the Department opened the Claimant's FIP then placed the Claimant's FIP into closure and reduced his FAP.

3. The Department budgeted [REDACTED] in unemployment income in determining FIP and FAP eligibility.

4. On November 11, 2008, the Claimant filed a request for a hearing.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the FAP program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, 8 USC 601, et seq. The Department of Human Services (formerly known as the Family Independence Agency) administers the FIP program pursuant to MCL 400.10, et seq., and MAC R 400.3101-3131. The FIP program replaced the Aid to Dependent Children (ADC) program effective October 1, 1996. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

In the instant case the Claimant questions the FAP benefit allowed and the FIP closure based on his unemployment income. The Department uses the following procedures in budgeting income that includes lump sum amounts:

Past Months

Use actual gross income amounts received for past month benefits, converting to a standard monthly amount, when appropriate (PEM 505, p. 2).

Here, the Claimant testified that the unemployment benefits the Department used to calculate his FIP and FAP was a lump sum amount making up for back benefits.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, REVERSES AND ORDERS the Department to recalculate the Claimant's FAP and FIP budgets based on documented unemployment benefits received.


