HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was conducted from Kalamazoo, Michigan on February 4, 2009.

ISSUE

Whether the Department is entitled to recoup an overissuance to Claimant due to a client error and Department error(s).

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

1. The Claimant is a FAP recipient.
2. As a result of Claimant's failure to report increased income for the months of

[REDACTED], Claimant received a [REDACTED] FAP
overissuance for [REDACTED]. (Exhibits 22 - 44)

3. As a result of the Department's failure to properly budget Claimant's husband's income for the period of [REDACTED], Claimant received an overissuance of [REDACTED]. Due to another Department error, [REDACTED] benefits in the amount of [REDACTED] were never issued to Claimant. This reduced the amount of the overissuance to [REDACTED].

4. On November 10, 2008, the Department received the Claimant's written hearing request protesting the proposed recoupment action.

CONCLUSIONS OF LAW

The Food Assistance Program, formerly known as the Food Stamp ("FS") program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations ("CFR"). The Department of Human Services ("DHS"), formally known as the Family Independence Agency, administers the FAP program pursuant to MCL 400.10, *et seq* and MAC R 400.3001-3015. Departmental policies are found in the Program Administrative Manual ("PAM"), the Program Eligibility Manual ("PEM"), and the Program Reference Manual ("PRM").

In this case, the Department seeks recoupment of an overissuance of FAP benefits. An overissuance ("OI") occurs when a client group receives more benefits than they are entitled to receive. PAM 700, p. 1 A claim is the resulting debt created by the overissuance of benefits. PAM 700, p. 1 Recoupment is an action to identify and recover a benefit OI. PAM 700, p. 1 The Department must take reasonable steps to promptly correct any overpayment of public assistance benefits, whether due to department or client error. PAMs 700, 705, 715, and 725 An agency error OI is caused by incorrect actions by DHS, DIT staff, or department processes.

PAM 705, p. 1 In general, agency error OIs are not pursued if OI amount is under \$500.00 per program. PEM 705, pp. 1, 2, 3

In the record presented, Claimant failed to properly report income which resulted in a FAP overissuance. The Department also failed to properly budget Claimant's husband's income and failed to issue benefits which resulted in a net FAP overissuance. Ultimately, the Department established that the Claimant received a [REDACTED] FAP overissuance due to client and department error(s).

DECISION AND ORDER

The Administrative Law Judge, based upon findings of fact and conclusions of law, finds that the Claimant received a [REDACTED] FAP overissuance due to client and Department error(s).

Accordingly, it is ordered:

1. The Department's determination of a [REDACTED] FAP overissuance is AFFIRMED.
2. The Claimant shall be required to reimburse the Department the FAP benefits ineligibly received, due to client and Department error(s), in the amount of [REDACTED] in accordance with department policy.
