**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on October 26, 2010. Claimant appeared and testified.

**ISSUE**

Did the Department of Human Services properly deny Claimant's September 23, 2009 application for Adult Medical Program (AMP) benefits?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On September 23, 2009 Claimant submitted an application for Adult Medical Program (AMP) benefits. The Adult Medical Program (AMP) was closed to new applications at the time.
- (2) On September 23, 2009 Claimant was sent a Notice of Case Action (DHS-1605) stating his application for Adult Medical Program (AMP) benefits was denied.
- (3) October 5, 2009 Claimant submitted a request for hearing.

**CONCLUSIONS OF LAW**

The Adult Medical Program (AMP) is established by Title XXI of the Social Security Act; (1115)(a)(1) of the Social Security Act, and is administered by the Department of Human Services (DHS or department) pursuant to MCL 400.10, *et seq.* Department policies are contained in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

Department policy provides the following guidance for case workers. The Department's policies are available on the internet through the Department's website.

**BEM 640 ADULT MEDICAL PROGRAM**

**DEPARTMENT POLICY**

**DETERMINE IF AN ENROLLMENT FREEZE IS IN EFFECT BEFORE CONSIDERING ELIGIBILITY FOR THIS PROGRAM.**

**AMP Only**

The Adult Medical Program (AMP) is available to individuals who meet all the eligibility factors in this item. Certain aliens are limited to coverage of emergency services (ESO).

**ENROLLMENT FREEZE INSTRUCTIONS**

Applications received during the freeze on AMP enrollments must be registered and denied using "applicant did not meet other eligibility requirements" as the denial reason.

**DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides the Department of Human Services properly denied Claimant's September 23, 2009 application for Adult Medical Program (AMP) benefits.

It is ORDERED that the actions of the Department of Human Services, in this matter, are UPHeld.
