HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon claimant's request for a hearing to protest the denial of claimant's application for MA-P. After due notice, a three-way telephone conference hearing was held on January 20, 2010. Claimant was represented at the administrative hearing by [REDACTED]

ISSUE

Whether claimant meets the disability criteria for MA-P?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On 11/25/08, claimant applied for MA-P with the Michigan DHS.
- (2) Claimant applied for three months of retro MA.
- (3) On 6/18/09, MRT denied.

- (4) On 8/31/09, the department issued notice.
- (5) On 11/23/09, claimant filed a hearing request.
- (6) On 12/17/09, SHRT denied claimant.
- (7) At the administrative hearing, claimant's representative indicated that he believed claimant was approved benefits. The record was held open in this matter to give the representative an opportunity to submit proper verification. On 1/27/10, the undersigned Administrative Law Judge received verification from the representative showing that claimant was approved Social Security with a disability onset date of April 1, 2007. There are no months left for review.

#### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

#### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical Assistance program as of the 11/25/08 application date and including three months of retro MA,

if otherwise eligible. The department shall review this case in accordance with its usual policy and procedure.
