#### **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing. After due notice, a telephone hearing was held on June 21, 2010. The claimant appeared and testified. The claimant was represented by his Authorized Representative (AR).

# <u>ISSUE</u>

Did the Department properly deny/close the claimant's Medical Assistance (MA) and retroactive MA applications?

#### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds a material fact:

- On November 25, 2008, the claimant filed an application for MA and retroactive MA.
- 2. On November 2, 2009, the department denied the claimant's MA.
- 3. On September 25, 2009, the claimant filed a request for a hearing.

### **CONCLUSIONS OF LAW**

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The client must obtain required verification, but you must assist if they need and request help. (BAM 130, p. 3)

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24. 278(2). In the instant case, the parties reached an accord. The department agreed to reregister the claimant's MA application of November 25, 2008.

# **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law finds that the department and claimant have come to an agreement and ORDERS the department to reregister the claimant's MA and retroactive applications of November 25, 2008.
