HEARING DECISION

This matter is before the undersigned Administrative Law Judge upon pursuant to MCL

400. 9; MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone

hearing was held on February 24, 2010. The Claimant appeared and testified.

FIM appeared on behalf of the Department.

<u>ISSUE</u>

Was the Department correct in denying Claimant's FAP, SER, and Medicaid application?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial

evidence on the whole record, finds as material fact:

- (1) Claimant applied for FAP, MA, and SER on November 1, 2009.
- A verification checklist was sent to Claimant on December 1, 2009 with a December 11, 2009 due date.
- (3) The deadline for the checklist was extended to December 14, 2009.

- (4) The Department contacted the Claimant by telephone to inform him of the extension and to request the verifications again.
- (5) Verifications were not received and the case closed.
- (6) Claimant requested a hearing on December 10, 2009 regarding the denial of his applications.

CONCLUSIONS OF LAW

The Food Assistance Program, formerly known as the Food Stamp ("FS") program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations ("CFR"). The Department of Human Services ("DHS"), formally known as the Family Independence Agency, administers the FAP program pursuant to MCL 400.10, *et seq* and MAC R 400.3001-3015. Departmental policies are found in the Program Administrative Manual ("PAM"), the Program Eligibility Manual ("PEM"), and the Program Reference Manual ("PRM").

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Emergency Relief ("SER") program is established by 2004 PA 344. The SER program is administered pursuant to MCL 400.10, *et seq.* and by final administrative rules filed with the Secretary of State on October 28, 1993. MAC R 400.7001-400.7049. The Department

of Human Services' [formally known as the Family Independence Agency] policies are found in the State Emergency Relief Manual ("ERM").

Clients must cooperate with the local office in determining initial and ongoing eligibility to provide verification. PAM 130, p. 1. The questionable information might be from the client or a third party. <u>Id.</u> The Department can use documents, collateral contacts or home calls to verify information. <u>Id.</u> The client should be allowed 10 calendar days to provide the verification. If the client cannot provide the verification despite a reasonable effort, the time limit to provide should be extended at least once. PAM 130, p.4; PEM 702. If the client refuses to provide the information or has not made a reasonable effort within the specified time period, then policy directs that a negative action be issued. PAM 130, p. 4. Before making an eligibility determination, however, the department must give the client a reasonable opportunity to resolve any discrepancy between his statements and information from another source. PAM 130, p. 6.

In the present case, Claimant was sent a checklist on December 1, 2009 requesting verifications. The Department extended the deadline for the checklist and followed up with a phone call requesting the same verifications. No verifications were received and the case was closed. Claimant testified that he did not receive the checklist and that he may have received the phone call but that he did not remember. Claimant acknowledged receiving the notice of the hearing by mail. The Department presented adequate proof that Claimant had notice of the requested verifications prior to the closure; therefore denial of Claimant's application was proper.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law decides that the Department was correct in the denial of FAP, MA, and SER benefits, and it is ORDERED that the Department's decision in this regard be and is hereby AFFIRMED.
