#### HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on June 1, 2010.

#### **ISSUE**

Was the claimant's FAP allotment computed and allocated correctly?

### **FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant was a FAP recipient in Macomb County.
- Claimant was a Medicaid recipient.
- (3) Claimant's FAP budget was run after a redetermination and claimant's budget indicated claimant was eligible for FAP benefits in the amount of \$451.
- (4) Claimant's MA case was determined to have a deductible.

- (5) Claimant filed for hearing on December 14, 2009, alleging that DHS incorrectly computed his budget.
- (6) During the hearing, the Department acknowledged that claimant's Medicaid deductible case was incorrect and agreed to fix the problem.

#### CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

While claimant initially had a dispute with regard to his Medicaid benefits, this dispute was resolved during the hearing; the Department agreed to make the corrections to the case and restore Medicaid benefits. Claimant was satisfied by this result and agreed to drop his request for hearing in the matter.

When determining eligibility for FAP benefits, the household's total income must be evaluated. All earned and unearned income of each household member must be included unless specifically excluded. BEM, Item 500. A standard deduction from income of \$132 is allowed for each household. Certain non-reimbursable medical expenses above \$35 a month may be deducted for senior/disabled/veteran group members. Another deduction from income is provided if monthly shelter costs are in excess of 50% of the household's income after all of the other deductions have been allowed, up to a maximum of \$459 for non-senior/disabled/veteran

households. BEM, Items 500 and 554; RFT 255; 7 CFR 273.2. Only heat, electricity, sewer, trash and telephone are allowed deductions. BEM 554. Any other expenses are considered non-critical, and thus, not allowed to be deducted from gross income. Furthermore, RFT 255 states exactly how much is allowed to be claimed for each deduction.

In this case, the Administrative Law Judge has reviewed the FAP budget and finds that the Department properly computed the claimant's gross income. The gross unearned income amount must be counted as income, which is \$967 in the current case, before any deductions.

BEM 500. These amounts were verified by the claimant during the course of the hearing.

The federal regulations at 7 CFR 273.10 provide standards for the amount of a household's benefits. Claimant verified that his rent and housing expense deduction was accurate. Claimant was given a utility deduction. The Administrative Law Judge computed claimant as having a net income of \$247 dollars. The Department, in compliance with the federal regulations, has prepared issuance tables which are set forth at Bridges Reference Manual, Table 260. The issuance table provides that a household with household size and net income of the claimant is eligible for an FAP allotment of \$451. The Administrative Law Judge has reviewed the budget and found no significant errors. Claimant was unable to point out specifically what parts of the budget he felt were in error. Therefore, the undersigned finds that the Department correctly determined the claimant's FAP allotment of \$451.

#### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department's decision to award claimant a FAP allotment of \$451 was correct.

Accordingly, the Department's decision is AFFIRMED.

The Department is ORDERED to issue the necessary corrections to claimant's MA eligibility levels.
